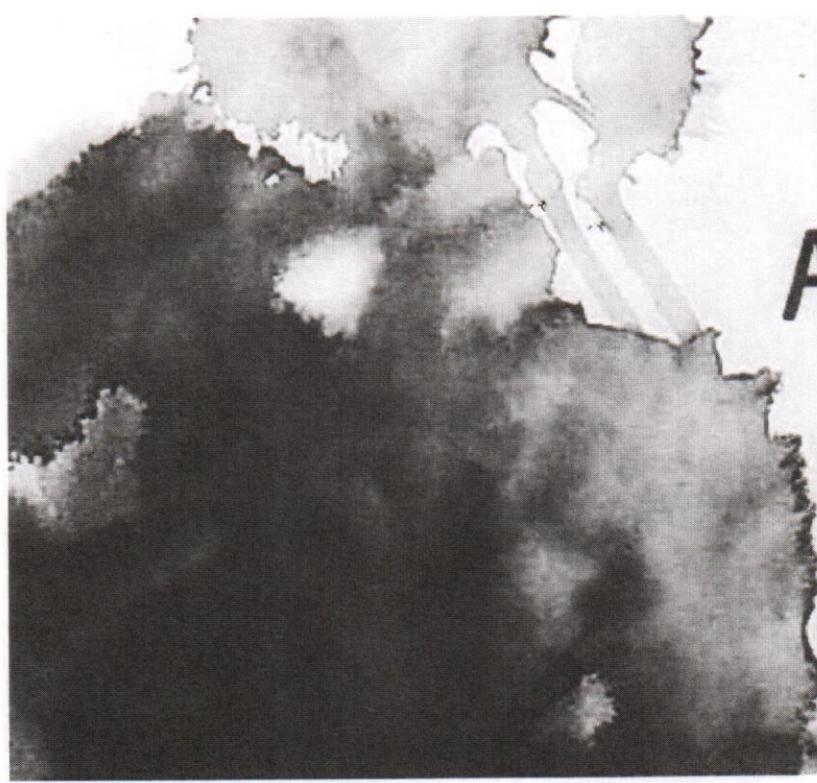



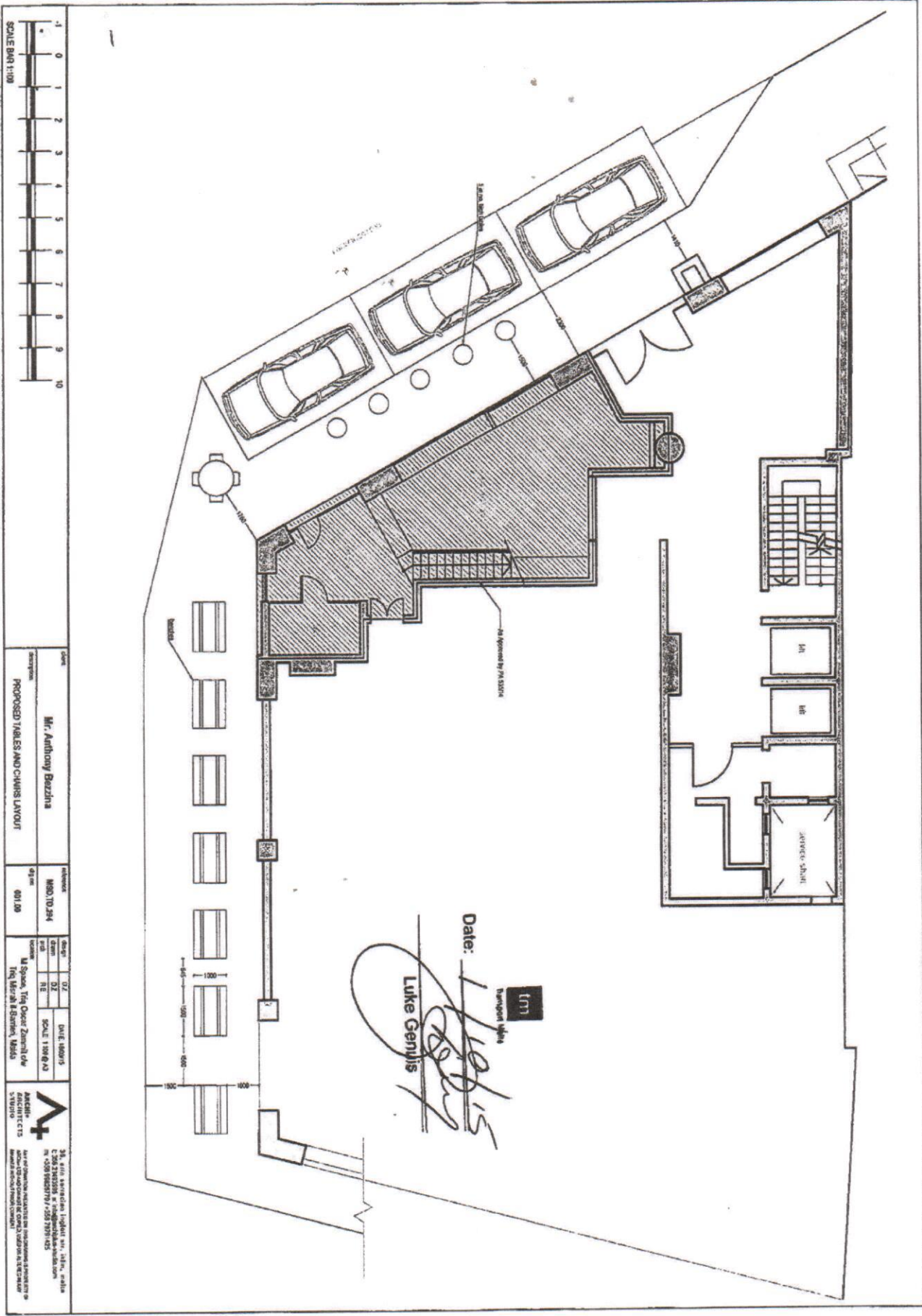
Kindly be informed that Transport Malta finds no objection for the proposed timber platform and tables and chairs in the proposed location in front M Space, Triq Oscar Zammit c/w Triq Mistrah il-Barrieri, Msida as indicated in the attached layout plans.

The following conditions refer:

1. Tables and chairs are not to obstruct the free flow of pedestrians.
2. A minimum of 1.5 meters is to be left between the shop façade and any outdoor equipment
3. Any umbrellas and/or outdoor heating equipment are to be located within the group of tables and chairs and are not to protrude beyond the area allocated for tables and chairs.
4. Permits for the setting up of tables and chairs are to be sought from the relevant authority/ government body.
5. Third party rights are not to be effected.
6. Tables and chairs are not to pose a safety hazard to pedestrians.
7. The Malta Transport Authority and the Malta police reserve the right to remove all street furniture as required for safety reasons and on special occasions. The Local council may remove street furniture for safety reasons.

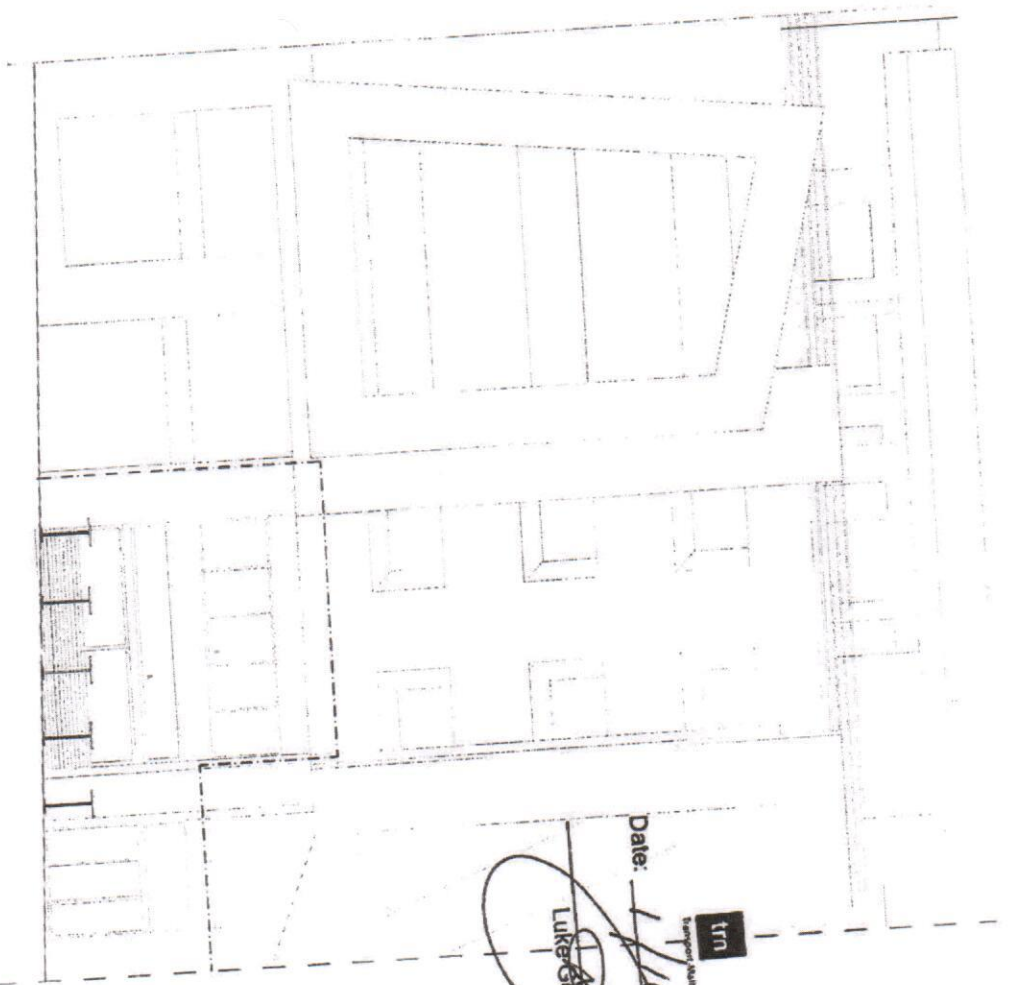

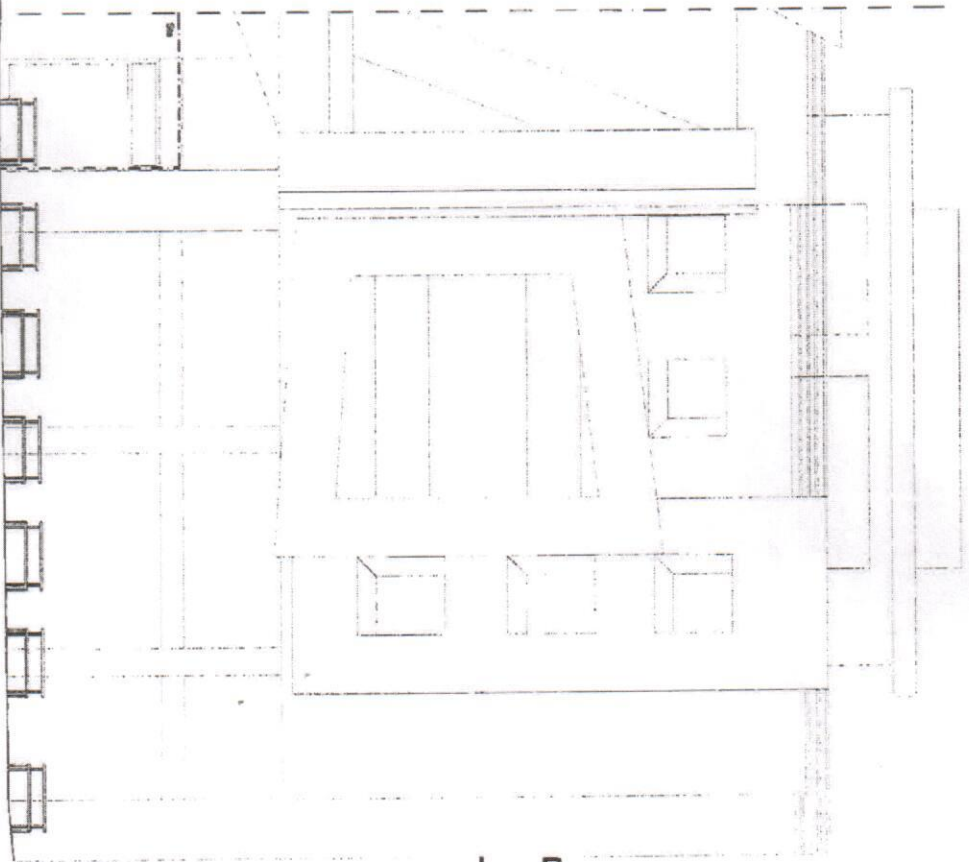
