- 3.2. 7.5. Il-Kunsill għalhekk iddeċieda li, qabel ma jkkunsidra t-talba tas-Sinj. Zammit Tabona, għandu jgħamel pressjoni fuq il-kuntrattur, u jekk il-Kunsill ma jkollux risposta sa xahar u nofs oħra, il-Kunsill għandu jipproċedi li joħroġ sejha oħra għall-offerti.
