#### 1. APOLOĠIJI

#### 2. APPROVAZZJONI TAL-MINUTI

- 3.2. Is-SE informa li, skont artiklu 18 tal-Att dwar il-Kunsilli Lokali, huwa kellu l-obbligu li jinforma lis-Sindku meta Kunsillieri ikun naqas li jattendi għal erba' laqqgħat konsekuttivi tal-Kunsill jew b'kolloxx ikun naqas li jattendi għal iktar

minn terz tal-laqqhat imsejja fi żmien sitt xhur. Huwa għamel dan fir-rigward tal-Kunsillier Pauline Miceli li kienet naqset li tattendi għal aktar minn terz tal-laqqhat f'sitt xhur. Huwa kellu l-obbligu wkoll li jinforma lill-Ministru b'dan iżda qabel ried iressaqha għall-attenzjoni tal-Kunsill ħalli l-Kunsill ikun jista' jikkonferma jekk dan in-nuqqas kienx għal raġuni ġusta biex meta jinforma lill-Ministru jgħaddi r-rakkomandazzjoni tal-Kunsill biex ma jiddikjarax il-post vakant.
