1. APPOLOĠIJI

- 1.1. Is-SE informa li l-Viċi Sindku kienet infurmatu permezz ta' *email* li ma setgħetx tattendi għal-laqqgħa għaliex ma kinitx tiflaħ. Il-Kunsillier Sammut ukoll kien infurmah bit-telefon li inqabad xogħol u s-SE talbu jibgħat email. Madanakollu l-email li bgħat aktar kmieni kienet vojta. Kopji tal-emails imsemmija huma annessi f'A.
- 1.2. Iċ-Chairperson tal-Kumitat Amministrattiv ta' Baħar iċ-Ċagħaq infurmat lis-SE li ma setgħetx tattendi minħabba impenji oħra.
- 1.3. Il-Kunsillier Miceli kienet infurmat lis-SE li kienet se tasal tard għal-laqqgħa.
- 1.4. F'dan il-ħin il-Kunsillier Sciberras staqsa dwar il-possibilità li l-laqqgħat tal-Kunsill jergaw jibdew isiru nhar ta' Tlieta għaliex għalih kien impossibli li l-Ħamis idum aktar mit-tmienja avolja kien jipprova jdum aktar.
- 1.5. Is-SE fakkar li l-laqqgħat kienu ġew imressqa għal nhar ta' Ħamis minħabba li l-Kunsillier Sammut kellu xi *lectures* l-università nhar ta' Tlieta. Intqal però li anki l-Ħamis il-Kunsillier Sammut kien qiegħed ifalli relattivament spiss.
- 1.6. Dak il-ħin is-SE ċempel lill-Kunsillier Sammut b'mod li setgħu jisimgħu il-membri kollha preżenti bil-ħsieb li tkun riżolta din il-problema. Il-Kunsillier

Sammut informa li kien inqabad xogħol u ma setax jitlaq u li wkoll kull nhar ta' Tlieta jkollu l-*lectures*. Huwa informa wkoll li ma jkollux aktar problema mil-*lectures* la jibda s-sajf. .

- 1.7. Il-Kunsillier Sciberras tenna li huwa ma kellu l-ebda problema jekk il-laqqgħat isiru t-Tlieta iżda jekk jibqgħu isiru l-Ħamis kellu impenji li bilfors ikollu jitlaq kmieni mil-laqqgħa.
- 1.8. Wara diskussjoni kien hemm qbil li għalissa l-laqqgħat jibqgħu jissejħu l-Ħamis sas-sajf.

2. APPROVAZZJONI TAL-MINUTI

- 2.1. Is-SE ressaq il-minuti tal-laqqgħa preċedenti li kienu meqjusa moqrija. Il-minuti ġew approvati u ffirmati mis-Sindku u mis-SE.

3. KOMUNIKAZZJONIJIET MIS-SINDKU U KORRISPONDENZA

- 3.1. F'dan il-ħin giet interrotta l-laqqgħa biex il-Kunsill jisma t-talba tal-persuna preżenti (is-Sur Ciappara). Il-ħin kien it-19.43.
- 3.2. Is-Sur Ciappara talab biex il-Kunsill isib soluzzjoni biex jithalla li jsir parkeġġ fi Triq San Pawl wara r-rawndebawt tal-GS fejn hemm *centre strip* żgħira.
- 3.3. Ir-resident sostna li l-wardens qed jgħatu ċitazzjonijiet għal min jipparkja hemm għaliex ikunu qed jostakolaw it-triq. Skond ir-resident fir-realtà karożzi pparkjati hemm ma joħolqux ostaklu u għalhekk talab lill-Kunsill biex jithalla l-parkeġġ f'din iż-żona.
- 3.4. F'dan il-ħin waslet il-Kunsillier Miceli. Il-ħin kien 19.47.
- 3.5. Il-Kunsill iddeċieda li jara x'jista' jsir biex jithalla l-parkeġġ.
- 3.6. F'dan il-ħin tkomplet il-laqqgħa. Il-ħin kien 19.48. Minn dan il-ħin ma kien hemm l-ebda preżenza ta' pubbliku.
- 3.7. Is-Sindku infurmat li kien hemm possibiltà li bil-*planning gain* tal-iżvilupp tat-*traded fair grounds* jinbena r-*Respite Centre* li qed jipproponi l-Kunsill lill-Gvern Ċentrali.
- 3.8. Issemmiet ukoll il-possibiltà li tinbena zona ta' parkeġġ bil-*planning gain*, iżda kien hemm qbil li r-*Respite Centre* tingħata l-prijorità.
- 3.9. Il-MEPA saqsew dwar il-konfini taċ-ċentru tal-lokalità, iżda l-mistoqsija ma kinitx ċara u għalhekk għandha tintalab kjarifika dwar l-estent.
- 3.10. Kien hemm qbil li tissejjaħ laqqgħa ma rappreżentanti tal-MEPA sabiex il-Kunsill ikun jista' jagħti risposta ċara u waħda li tkun fl-interess tal-lokalità.
- 3.11. Is-SE informa li dwar il-każ tal-ħalib tal-GS, It-TM kienu irrispondew lill-GRTU mingħajr ma talbu l-kummenti tal-Kunsill.
- 3.12. Il-Kunsillier Sciberras talab li jkun skużat mill-kumpliment tal-laqqgħa. Il-ħin kien it-20:14.
- 3.13. Is-SE ressaq ittra mill-MEPA li tinforma li mill-Fondi tal-UIF hemm ċans li parti minnhom se jkunu jridu jiġu allokati bilfors għal bini ta' *boundary walls*.
- 3.14. Kien maqbul li l-Kunsill għandu joġġezzjona għal din id-deċiżjoni.
- 3.15. Is-SE informa li l-korsijiet tal-iKIDS ta' TCTC se jerġgħu jsiru fis-sajf. Il-Kunsill qabel li għandu jerġa joffri dawn il-korsijiet.

- 3.16. Is-SE informa ukoll li hemm sejha għall-Enterprise Awards. Informa ukoll li bħal issa qed tiġi ifformulata l-applikazzjoni biex il-Kunsill jieħu sehem f'dawn l-Awards.
- 3.17. Il-Kunsillier Gatt informa li kien attenda għal laqgħa ma' TM rigward ix-xogħlijiet li se jsiru fi Triq il-Kosta. Informa li l-proġett huwa ppjanat li jdum 54 ġimgħa. It traffiku lejn it-tramuntana ta' Malta mhux se jkun imwaqqaf. Traffiku li jkun ġej minn San Pawl il-Baħar ikun wieqaf għal 11-il ġimgħa biss.
- 3.18. Informa ukoll li mill-54 ġimgħa hemm 6 xhur minnhom 'żejda' biex jekk jinstabu xi siti storiċi, jkun hemm ħin biż-żejjed sabiex dawn ma ssirihomx ħsara u jittkompla x-xogħol. Jekk ix-xogħlijiet jittardjaw aktar min 54 ġimgħa jintilfu l-fondi mill-UE.
- 3.19. Is-SE informa li wasal ilment mis-Sur Angelo Vassallo, li jgħix San Gwann, li kien qed joġġezzjona għall-għeluq tal-*picnic area* tas-Salina. Is-SE spjega kif il-*picnic area* qed tingħalaq minhabba li ġiet identifikata bħala l-aqwa post biex isservi bħala *site office* għal waqt ix-xogħlijiet li se jsiru fi Triq il-Kosta. Meta x-xogħlijiet jitlestew, il-*picnic area* terġa tinfetaħ kif kienet.
- 3.20. Wara diskussjoni qasira, kien hemm il-qbil li tintbagħat risposta lis-Sur Vassallo li tgħid li m'hemmx alternattivi oħra, u l-*picnic area* se jkollha tibqa' magħluqa.
- 3.21. Is-Sindku infurmat li kienet saret laqgħa mal-Ministru Marie Louise Coleiro Preca rigward ir-*Respite Centre*. Is-Sindku spjegat kif din l-idea intlaqgħet tajjeb, u se ssir talba mill-Ministru biex isiru aktar laqgħat mal-kabinett.
- 3.22. Il-Kunsillier Bonnici ta informazzjoni dwar il-wirja li hija ppjanata fi Piemonte l-Italja u li dalwaqt se jkun hemm aktar informazzjoni mill-MAGF.

- 5.2. Il-Kunsillier Agius informa li l-Kunsill Lokali taz-Żgħażaġĥ kien qiegħed jinnomina lil Ishmael Ellul.
- 5.3. Il-Kunsill qabel li s-Sur Ellul isir l-Ambaxxatur taz-Żgħażaġĥ.

6. PROĠETT TAHT IL-PROGRAMM ERASMUS+

- 6.1. Is-SE informa li kienu qed isiru taħdidiet biex isir proġett ta' *student exchange* taht il-Programm tal-UE Erasmus+.
- 6.2. Jidher li min-naħa ta' Mornago se jkomplu bil-proġett minhabba nuqqas ta' rizersi umani, u l-Kunsill se jkollu jfittex lil xi ħadd ieħor. Għalhekk mhux se titlaħħaq id-*deadline* li jmiss biex tkun sottomessa l-applikazzjoni.
- 6.3. Kien hemm qbil li jkompli x-xogħol fuq dan il-proġett għall-eventwali applikazzjonijiet futuri.

7. PROPOSTA DWAR IRRANĠAR TA' TOROQ

- 7.1. Meta mistoqsi mis-Sindku l-Kunsillier Galea informa li kien tkellem mal-Ministeru tat-Trasport dwar bżonn ta' għajnuna għall-irranġar ta' toroq iżda ntalab proposta ta' toroq.
