1. APPROVAZZJONI TAL-MINUTI

- 1.1. Is-Segretarju Eżekuttiv (SE) ressaq il-minuti tal-laqgħa preċedenti li kienu meqjusa moqrija.
- 1.2. Il-minuti ġew approvati u ffirmati mis-Sindku u mis-SE.
- 1.3. Il-Viċi Sindku staqsiet dwar is-sitwazzjoni tax-xogħlijiet għaddejin fis-Salina. Is-Sindku infurmat li l-Kunsill talab laqgħa, però kien għadu ma rċieva l-ebda risposta. Infurmat ukoll li xi residenti fetħu mandat kontra TM. Il-Viċi Sindku staqsiet jekk il-Kunsill jistax jagħmel xi ħaġa dwar dan. Is-Sindku wiegħbet li m'hemm xejn x'jista' jsir mill-Kunsill.
- 1.4. Il-Viċi Sindku staqsiet jekk hemmx xi ħjiel meta se jibda l-proċess tat-tabelli tan-negożji. Is-SE informa li minħabba ammont kbir ta' xogħol ma jistax jgħid eżatt meta se jkun f'pożizzjoni li joħroġ l-offerti.
- 1.5. Il-Kunsillier Sammut informa lill-Kunsill li l-approvazzjoni għall-annimali waqt l-attività tal-Milied kienet għadha ma waslitx.

Hija sostniet li l-Kunsill għandu jqabba xi ħadd ieħor biex jgħati parir lill-Kunsill, u dawn jithallsu mill-Kumpanija li l-Kunsill għandu kuntratt magħha. Dwar dan il-Kunsill qabel li għandu jieħu parir legali.
- 2.5. Is-SE informa li l-applikant tat-tabella direzzjonali ta' Ta Stringi, talab lil Kunsill biex it-talba terġa tiġi kkunsidrata. Il-Kunsill ma qabilx għaliex ħass li d-deċiżjoni ma tistax tinbidel.
- 2.6. Il-Kunsillier Sciberras informa li n-Naxxar Lions jixtiequ jagħmlu *banner* mal-*multipurpose pitch* biex jippromwovu attività ta' *fund raising* li għandha ssir fit-22 ta' Diċembru. Il-Kunsill qabel.
- 2.7. F'dan il-ħin il-laqgħa ġiet sospiża għal ftit minuti sabiex il-Kunsill Lokali taż-Żgħażaġh jagħti tifikira lill-Kunsill.
