- 1.1. Is-Segretarju Eżekuttiv (SE) informa li l-Kunsillier Galea ma kienx jiflaħ u għalhekk ma setax jattendi. Kopja tal-email mibgħuta mill-Kunsillier Galea hija annessa f'A.

#### 2. IL-PROĠETT AUTHENTIC EUROPE NETWORK FIN-NAXXAR

- 2.1. Il-Kunsill qabel li jiddiskuti l-ewwel parti ta' dan is-suġġett u stieden lis-Sur Julian Zarb biex jagħmel preżentazzjoni minhabba li se jkun qiegħed jassisti lill-Kunsill volontarjament fuq dan il-proġett.
- 2.2. Is-Sur Zarb fakkar li t-tema hija propju l-isem tal-proġett filwaqt li huwa essenzjali biex kemm jista' jkun l-attivitajiet isiru kollha fin-Naxxar. Fakkar ukoll li dan huwa proġett tal-komunità u għalhekk importanti li l-Kunsill jinvolviha kemm jista' jkun.
- 2.3. F'dan il-ħin kien ipprezentat abbozz ta' programm li kien imħejji mill-Kunsilliera Maryanne Cuomo, is-Sur Zarb u s-SE.
- 2.4. Il-Kunsill qabel mal-abbozz tal-programm u awtorizza li jkompli l-proċess fuq dik il-linja.
- 2.5. Is-Sur Zarb wiegħed ukoll l-assistenza tal-istudeni barranin filwaqt li kienu mitluba jintroduċu lilhom infushom.

- 2.6. Il-Kunsill imbagħad irringrazzja lis-Sur Zarb.
- 2.7. Il-Kunsill qabel li jgħaddi immedjatament għas-suġġett numru 9 fuq l-aġenda dwar il-ġbir ta' skart separat.

### **3. ĠBIR TA' SKART SEPARAT U REVIŻJONI TAL-POSTIJET TAL-BRING IN SITES (BIS)**

- 3.1. Fid-dawl tal-ftehim il-ġdid ma' GreenPak, u minħabba li se tibda ssir promozzjoni biex aktar nies jisseparaw l-iskart, il-Kunsill iddiskuta s-suġġeriment li mill-1 ta' Ġunju l-ġbir tal-borża l-ħadra (li qabel kienet griża) jibda jsir it-Tlieta u l-Ġimgħa minflok it-Tlieta u l-Ħamis.
- 3.2. Dwar il-lokazzjoni tal-BIS il-Kunsill iffoka fuq dik ta' Triq l-Imdina li kien hemm reżistenza mir-residenti għaliha. Is-SE spjega li minkejja li kien hemm l-intenzjoni li qabel ma jitpoġġew tintbagħat ittra lir-residenti, ma laħqux ħarġu l-ittri qabel ma bdew ikunu installati fil-post miftiehem ma' GreenPak.
- 3.3. Wara diskussjoni kien hemm qbil li dawn ma jitpoġġewx fil-post imsemmi.
- 3.4. Sadanittant il-Kunsill kien infurmat ukoll li dawk li kien hemm aktar 'l isfel tneħħew.
- 3.5. F'dan il-ħin il-Kunsillier Sciberras talab li jkun skużat mill-kumplament tal-laqgħa. Il-ħin kien it-20:34.
- 3.6. Il-Kunsill qabel li jddiskuti s-suġġetti numru 4 u 5 fuq l-aġenda u għalhekk stieden lill-Accountant Romina Perici Ferrante biex tispjega r-rapporti.

- 6.6. Dwar punt numru 5.4 il-Viċi Sindku infurmat li għada qed tistenna xi kwotazzjonijiet iżda diġà tħawwlu numru kbir ta' fjuri. Infurmat li saret l-arma tan-Naxxar bil-fjuri fil-Pjazza u tħawwlu s-siġar Cercis fit-triq maġenb il-bandli.
- 6.7. Is-Sindku ipproponiet li qabel mal-fjuri li jiffurmaw l-arma jiġu mibdula, il-ħamrija għandha tiġi elevata minn wara biex l-arma tidher aħjar. Il-Kunsill qabel.
- 6.8. Dwar punt numru 7.1 il-Viċi Sindku infurmat li kienet infurmata li jekk ikollna bżonn assistenza I-ELC jistgħu jgħinnuna biex niddisinjaw il-ġnien.
- 6.9. Il-Viċi Sindku infurmat li l-kors tal-ġarnidaġġ spiċċa u marru tajjeb għalkemm ma sarx promozzjoni biżżejjed.
- 6.10. Il-Kunsilliera Miceli semmiet punt numru 3.15 fejn infurmat li kienet attendiet għal-laqqgħa tal-LEAP filwaqt li aċċetta li jipparteċipa wkoll is-Sur Charles Miceli. Kien hemm 18-il parteċipant u diversi entitajiet. Kunsilli Lokali kienu preżenti biss in-Naxxar u l-Mellieħa. Infurmat ukoll li kienu qed jaħdmu fuq study visit fl-Irlanda.
- 6.11. Dwar punt numru 6.4 il-Kunsillier Cuomo infurmat li kienet ivverifikat il-kmamar tal-lukanda u sabithom tajbin. Dawn kienu jħarsu fuq il-bitha. Hija rnexxiela wkoll tirraġġa biex jingħataw *welcome drink*.

## 7. KOMUNIKAZZJONI MIS-SINDKU U KORRISPONDENZA

- 7.1. Is-SE ta rapport dwar iż-żjara fil-Greċja bħala parti mill-proġett Authentic Europe Network. Huwa informa li ż-żjara kienet tajba filwaqt li d-deċiżjoni tal-Kunsill li jkun hemm preżenti s-Sur Julian Zarb kienet għaqlija ħafna u li tat riżultati tajbin. - 7.3. Il-Kunsill qabel li għaž-żjara fi Strumyani, li kellha t-tema aktar iffukata fuq l-arti u n-negozju, il-Viċi Sindku għandha tidentifika żewġ persuni mill-qasam tan-negozju u li possibilmment għandhom ikunu mill-aktar li jaħdmu. Il-Kunsill qabel li bħala artisti għandu jidentifika persuni li wkoll huma attivi f'dan il-qasam u li jgħinnu lill-Kunsill.

- 7.6. Is-SE ressaq talba għall-permess biex jitwaħħal banner b'reklam kummerċjali. Il-Kunsill qabel li dawn għandhom jirreferu lill-MEPA iżda per prinċipju iddikjara kontra banners kummerċjali fit-toroq.

- 7.7. F'dan il-ħin il-Kunsilliera Miceli kienet skużata mill-kumplament tal-laqqgħa. Il-ħin kien l-21:55.
- 7.8. Is-SE ippreżenta applikazzjoni mingħand Hilltop Gardens biex ipogġu 18-il tabella direzzjonali. Huwa ppreżenta il-pjanta fejn huma mixtieqa kif ukoll id-disinn innifsu. - 7.11.
