#### 1. APOLOĠIJI

- 1.1. Is-Segretarju Eżekuttiv (SE) informa li l-Kunsillieri Galea, Gatt u Cuomo infurmawh li kienu se jaslut tard għall-laqgħa.

#### 2. APPROVAZZJONI TAL-MINUTI

- 2.1. Is-SE ressaq il-minuti tal-laqgħa preċedenti li kienu meqjusa moqrija. Il-minuti ġew approvati u ffirmati mis-Sindku u mis-SE.

#### 3. KOMUNIKAZZJONI MIS-SINDKU U KORRISPONDENZA

- 3.1. Is-Sindku infurmat li l-Kunsill kien qabel li jipparteċipa minn qabel għall-okkażjoni ta' *Light up the Night*, billi jdawwal il-faċċata tal-Kunsill. Spjegat li l-kumpanija Transient offrew li jdawlu l-faċċata tal-Kunsill bla ħlas.
- 3.2. Is-SE informa li l-Viċi Sindku ġiet avviċinata biex il-Kunsill jidhol fi proġett ta' studju kongunt dwar l-iskart. Dan il-proġett jikkonsisti fi studju biex jiġi identifikat, mill-iskart li jintrema, li jkun jista jintuża bħala *fuel* għall-Biogas Plant. Skont din il-kumpanija, il-MEPA huma lesti li jiffinanzjaw €300,000 għal dan l-istudju. Għal dan, il-kumpanija li qed tiegħu ħsieb se tressaq applikazzjoni lill-MEPA għall-finanzjament. Il-Kunsill mhux se tinvolviha spejjeż. Il-Kunsill qabel li jipparteċipa.
- 3.3. Fir-rigward tal-għajjnuna taħt l-iskema tal-libreriji il-Kunsill qabel li japplika bħas-soltu.

- 3.4. Is-Sindku infurmat li l-attività Let's do it! Malta giet ikkanċellata minħabba x-xogħol li qed isir fi Triq il-Kosta.
- 3.5. Is-SE informa li kien wasal appell fuq deċiżjoni li kien ħa l-Kunsill fil-laqqgħa preċedenti mingħand Hilltop Gardens dwar il-kulur tat-tabelli li talbu l-permess li jwaħħlu madwar ir-raħal. Is-Sindku avżat li l-Kunsill irid joqgħod attent sabiex ma joħloqx preċedent. Hija staqsiet lis-SE jekk il-Kunsill jistax imur lura mid-deċiżjoni meħuda. Is-SE wieġeb illi, għalkemm il-By Law ma titkellimx dwar appelli, jekk wieħed iquis regolamenti u liġijiet oħra dwar applikazzjonijiet (inklużi dawk tal-permessi), dawn normalment jgħatu l-opportunità lil wieħed li jappella mid-deċiżjoni u għalhekk iħoss li l-Kunsill m'għandux iċaħħad lill-applikant milli jappella u għalhekk awtomatikament il-Kunsill jista' jirrikonsidra d-deċiżjoni. Il-Kunsillier Sciberras sostna li l-Kunsill m'għandux jitlob li t-tabelli jkollom kulur jekk mhux skont il-logo tal-entità għax dak ikun il-*brand* tal-kumpanija u allura ma jinbidilx.
- 3.6. F'dan il-ħin wasal il-Kunsillier Gatt. Il-ħin kien it-19:50.
- 3.7. Is-SE informa lill-Kunsill li, għalkemm il-Kunsill addotta din il-*policy* tal-kuluri tat-tabelli ta' direzzjoni, teknikament m'għandux bażi legali u għalhekk jista jkun li l-applikant ifittex lill-Kunsill legalment.
- 3.8. Wara diskussjoni kien hemm qbil li deċiżjonijiet b'hal dawn għandhom jittieħdu b'mod individwali għal kull kaz u mhux b'mod ġenerali. Għalhekk kien hemm il-qbil li jilqgħu l-appell u tinbidel id-deċiżjoni preċedenti billi l-applikant jagħmel it-tabelli skont it-talba tiegħu u l-mudell li pprova għall-kunsiderazzjoni.
- 3.9. Is-Sindku fakkret li l-iskola primarja organizzat l-attività Healthy Week, fejn il-Kunsill ipparteċipa billi offra xi ikel. L-attività tidher li kienet suċċess.
- 3.10. Il-Kunsilliera Miceli infurmat li giet mistiedna minn LEAP biex tattendi żjara ta' studju fl-Irlanda. M'hemm l-ebda spejjeż għall-Kunsill Lokali.

Huwa importanti wkoll illi l-Kunsill ma jikkommettix ruħu għal miżuri qabel ma jkun finalizzat ir-rapport għaliex inkella jintilef l-iskop kollu. Is-SE saħaq li f'dan l-istadju, jekk il-Kunsill jaqbel li jipproċedi, huwa essenzjali li l-Kunsill jaqbel mal-kunċett u jibda billi jaqbel jew jirranġa fejn hemm elenkati il-problemi fir-rapport. Jekk il-Kunsill jibda billi jaqbel mal-lista ta' problemi u jkun irid isolvihom, allura dan ikun l-ewwel pass.

- 5.7. Is-Sindku sostniet li huwa importanti li jekk il-Kunsill imexxi dan il-proġett, il-membri kollha tal-Kunsill iridu jkunu lesti li jkunu kommessi sal-aħħar.
