Il-Viċi Sindku għamlet riferenza għall-para. 3.4 fejn esprimiet li taqbel perfettament mal-kontenut iżda xtaqet iżżid li kważi l-Kunsillieri kollha taw il-kontribut tagħhom bħala parteċipazzjoni u għalhekk għandhom ikunu msemija min huma b'rikonoxximent għall-isforz li għamlu. Infatti kienu biss il-Kunsillieri Sciberras u Sammut li m'attendew għall-ebda attività/laqgħa.
- 2.5. Is-Sindku semmiet li r-ringrazzjamenti kienu intiżi biss fuq bażi ta' organizzazzjoni.
