Pubbliku: Ma kienx hemm pubbliku preżenti għal-laqqgħa

Eżatt wara li ntqalet it-talba s-Segretarju Eżekuttiv (SE) fakkar li kull meta xi ħadd ma jkunx jista' jattendi għandu jinforma lis-SE bil-miktub u jagħti r-raġunijiet għal dan.

1. KUNSIDERAZZJONI U APPROVAZZJONI TAL-MINUTI

- 1.1. Il-minuti ġew meqjusa moqrija.
- 1.2. Il-Kunsillier Bonello ressaq emenda biex jinqata' para. 13.3 u biex in-numru 13.4 jinbidel għal 13.3. Il-Kunsill approva.
- 1.3. Il-Kunsillier Brincat ressaq emenda biex wara para. 9.3 jiddaħħal para. ġdid li jkun innumerat 9.4 b'dan il-kliem: *'Il-Kunsillier Brincat talab li kull korrispondenza relatata għandha titressaq quddiem il-Kunsill.'* Il-Kunsill qabel u għalhekk in-numru ta' para. 9.4 inbidel għal 9.5.
- 1.4. Il-minuti imbagħad kienu approvati kif emendati u ffirmati mis-Sindku u s-SE.

2. KOMMUNIKAZZJONIJIET MIS-SINDKU

- 2.1. Is-SE fakkar li, minħabba impenji bl-aħħar attivitajiet, kien prattikament impossibli li jlaħħaq jiġbor informazzjoni dwar żviluppi li seħħew mill-aħħar laqqgħa.
- 2.2. Il-Kunsillier Sammut ippreżenta poster/avviż li kien impoġġi fuq il-paġna tal-Facebook xi jiem qabel fejn kien fih informazzjoni skorretta. Is-SE informa li huwa kien neħħa dan l-

avviż immedjatament li nnutah filwaqt li kien bagħat jinforma lil min poġġieh li kellu jitneħħa minħabba li kien qed jirreferi għal attività bil-kollaborazzjoni tal-Kunsill li ma kinitx teżisti.

- 2.3. Il-Kunsillier Muscat Fenech Adami infurmat li hija kienet organizzat laqgħa bejn is-sottokumitat ta' Birguma flimkien mal-Ispettur tal-Pulizija Bernard Spiteri. Din il-laqgħa kienet l-aktar iffukata fuq il-problemi minn storbu frekwenti mill-funzjonijiet li jkun hemm f'Villa Arrigo. L-ispettur wiegħed li se jagħmel minn kollox biex jiżgura li r-residenti ma jkollhomx dan l-inkonvenjent.

3. FLAS TA' KONTIJET U RENDIKONTI TA' DĦUL U ORDNIJET

- 3.1. Is-SE ippreżenta l-lista ta' kontijiet pendenti. Is-SE informa li l-ewwel parti tal-lista kien hemm numru ta' pagamenti diġà maħruġa u li ma kinx koperti mill-ebda lista iżda li jew kienu jinkludu rifużjoni ta' flus ta' garanziji jew inkella kienu msemmija fil-minuti iżda mhux fuq il-listi. Il-lista kienet approvata (annessata f'A).
- 3.2. Is-SE ippreżenta wkoll ir-rendikonti tad-dħul u tal-ordnijiet għal Novembru. Dawn kienu approvati (annessi f'B u f'C rispettivament).

4. MATRIET ĠODDA FL-AMMINISTRAZZJONI TAL-KUNSILL

- 4.1. Is-SE informa li l-ETC kienu bagħtu lista ta' 153 persuni eliġibbli u li jirreġistraw fuq l-ewwel parti tar-reġistru tal-ETC. Sa dak il-ħin kienu applikaw madwar erbgħin persuna.

5. EVALWAZZJONI TAL-ATTIVITÀ TAL-MILIED

- 5.1. Il-Kunsillier Brincat staqsa kemm swew biex ingiebu l-*Big Friends Guggen Musik* u biex ġew imqassma l-*flyers*. Is-SE informa li *Big Friends Guggen Musik* swiet €1,000, eżatt bħas-sena ta' qabel, filwaqt li l-*flyers* swew €613 biex ġew stampati 55,000 *flyer* u €1099 għat-tqassim. Huwa spjega li tqassmu viċin il-50,000 *flyer* bieb bieb fil-lokalitajiet tan-Naxxar, Mosta, Mgarr, Mdina, Rabat, Mtarfa, San Pawl il-Baħar, Mellieħa, Għargħur, Iklin, B'Kara, Balzan, H'Attard u Hal Lija.
- 5.2. Il-Kunsillier Brincat iddikjara ruħu kontra li saru dawn it-tali spejjeż mingħajr ma kienu mressqa minn qabel quddiem il-Kunsill. Huwa kompli li kien jistenna mqar notifika bl-*email* kif ġieli sar. Huwa sostna li dan ma kienx il-mod kif kien sar f'każ simili sena ilu. Dakinhar, kompli l-Kunsillier Brincat, is-Sindku sejthet laqgħa b'urgenza għaliex il-Kunsillier Bonello kien ordna reklam għall-attività tal-Milied tas-sena l-oħra u li, skont hu, f'dik il-laqgħa l-Kunsill kien iddeċieda li m'għandux ikun hemm infiq jekk mhux bl-approvazzjoni tal-Kunsill. Huwa aċċenna wkoll għal incident ieħor tas-sena l-oħra li kienet tikkonċerna l-*Big Friends Guggen Musik* u li l-Kunsillier Galea kien imwiddeb għaliex ta struzzjonijiet kontra r-rieda tas-Sindku minkejja li hu kien responsabbli mill-Kultura. Sostna li qed jintuża kejl differenti skont kif ikun jaqbel.
- 5.3. Is-SE informa li tant kien issikat biż-żmien li ma kienx possibli li jibgħat l-*emails* lill-Kunsillieri. Barra minn hekk fluss li ma kien sar xejn straordinarju għall-fatt li, la darba l-Kunsill kien approva li ssir l-attività allura bilfors kellhom isiru ċertu spejjeż, inkluż il-promozzjoni. Huwa kompli li l-Kunsill kien iddeċieda biss li jkun hemm inqas infiq għall-attività mingħajr ma speċifika l-ammont u infatti kien sodisfatt li l-ispejjeż kienu madwar €4,000 inqas mis-sena l-oħra. Barra minn hekk huwa saħaq li għamel minn kollox biex ikun hemm aktar valur fi flus u konvint li hekk ġara. Dan kien jinkludi l-promozzjoni li fl-areġ ċar l-effettività tagħha bl-ammont ta' nies li kien hemm. Huwa kompli wkoll li f'attivitajiet passati kien aċċettat ukoll li, minħabba l-limitazzjoni ta' żmien, ikunu ordnati servizzi qabel ma jkunu mressqa fil-Kunsill.

- 5.4. Is-Sindku saħqet li la darba l-Kunsill kien se jiltaqa' wara li tgħaddi l-attività, ma kienx possibli li wieħed jistenna laqgħa tal-Kunsill u għalhekk dak li gie deċiż sar b'responsabbiltà u bbażat fuq dak li sar fil-passat. Hija sostniet li l-każ tal-Kunsillier Bonello kien differenti għal kollox milli qed jišhaq dwaru l-Kunsillier Brincat għaliex dak kien jitratta dwar il-metodu tar-reklamar u mhux dwar il-flus. Saħqet ukoll li anki dwar il-każ ta' *Big Friends Guggen Musik* tas-sena l-oħra kien differenti għaliex dawn segwew ordni kontra ta' ftehim li kien sar u li kienu spiċċaw daqqew inqas milli miftiehem minkejja li dan seta' gie evitat kieku l-Kunsillier Galea kkomunika magħha bit-telefon qabel ta l-ordni. Hija kompliet saħqet li, għall-kuntrarju, din is-sena, bl-istess flus tas-sena l-oħra, taw siegħa aktar servizz milli taw is-sena l-oħra.
- 5.5. Il-Kunsillier Bonello esprima li jaqbel li dan il-każ kien simili għal tiegħu u li, filwaqt li ma kienx kontra li sar dak li sar f'din id-darba, iżda saħaq li l-istess haġa kellha ssir sena ilu meta kien qiegħed jieħu ħsieb il-promozzjoni tal-attività hu. Fl-istess waqt wera nuqqas ta' qbil mal-Kunsillier Brincat fir-rigward tal-*Big Friends Guggen Musik* minħabba li s-SE kien bagħat abbozz ta' programm jiem qabel li kien jinkludi kollox u għalhekk ħass li, jekk kien hemm xi ħadd li ma kienx jaqbel kellu joġġezzjona qabel u mhux wara.
- 5.6. Wara li baqa' għaddej id-dibattitu dwar l-interpretazzjoni ta' x'kien ġara fil-laqgħa li kienet saret b'urġenza dwar il-każ tal-Kunsillier Bonello (laqgħa numru 25 tas-16 ta' Novembru 2011) is-SE intalab jesebixxi l-minuti. Minkejja li kienu esebiti, baqa' ma kienx hemm qbil dwar l-interpretazzjoni tagħhom. Is-SE saħaq li l-minuti ma kienu jindikaw bl-ebda mod li l-problema dakinhar kienet dwar infiq ta' flus iżda dwar nuqqas ta' qbil dwar kif kellu jsir ir-reklamar biex ikunu l-aktar effettivi.
- 5.7. Waqt dan id-dibattitu ħadu parti l-Kunsillieri kollha b'reazzjonijiet u ħsibijiet differenti dwar l-istqarrija tal-Kunsillier Brincat.
- 5.8. Is-SE appella biex issa li d-diskussjoni ġiet eżawrita u min kellu jagħmel il-punt jagħmlu, kien ikun aktar għaqli li l-Kunsill jagħmel evalwazzjoni ta' x'kien hemm tajjeb, x'kien hemm ħażin u fejn seta' jkun hemm titjib. Huwa kompla appella li ma jistax ikun li l-Kunsill, kull darba li jkun hemm attività, qed jerġgħu jinqalgħu kwistjonijiet dwar sentejn ilu għaliex dan spiċċa wassal biex anki l-pubbliku jassoċja attività ma' jew kontra l-Kunsill u/jew Kunsillieri. Dan żgur li ma jservix ta' ġid meta l-Kunsill kellu potenzjal hekk kbir.
- 5.9. Meta l-Kunsill imbagħad għadda biex jagħmel l-evalwazzjoni, il-Kunsillier Sammut u l-Viċi Sindku saħqu li jkun xieraq jekk darba oħra jsir il-Presejpu Ħaj għax kien hemm domanda għalih. Is-SE appella biex dwar dan il-Kunsill jara kif jagħmel halli jinvolvi nies min-Naxxar għaliex il-Presejpu Ħaj kien qiegħed jiswa wisq flus u kien ċert li kien hemm nies min-Naxxar li kapaci jagħmlu dan ix-xogħol.
- 5.10. Il-Kunsillier Sammut xtaq li jirringrazzja lill-Kunsill Lokali Żgħażaġh għall-impenn tagħhom biex ferrħu lit-tfal bil-kostumi tal-karattri ta' *Disney*. Huwa semma wkoll li dawn irnexxielhom jagħmlu riċerka minn madwar 120 persuna kollha min-Naxxar biex jibbażaw il-ħidma tagħhom fuq din ir-riċerka.
- 5.11. Il-Kunsillier Gatt semma' li tajjeb jekk dwar id-dawl tal-Milied il-Kunsill jaħseb aktar qabel. Is-SE informa li l-istess haġa tišhaq dwarha s-Sindku ta' kull sena iżda fir-realtà, sakemm ikun deċiż xi jrid isir u kif u anki biex wieħed jasal biex jiftiehem mal-barranin ma jkunx faċli. Huwa wera x-xewqa wkoll li jkun hemm aktar involviment mill-Kunsillieri u ta eżempju tal-bżonn li jiżdied id-dawl fin-naħa ta' fuq ta' Triq tal-Labour. Huwa saħaq li mhux faċli li tasal biex tfassal il-bżonn tad-dawl u li jkun ukoll Prattiku biex jinħadem, jintrama, jiżżarma u eventualment jintrefa.

- 5.12. Dwar il-promozzjoni kien hemm qbil li kif saret kienet effettiva ħafna.
- 5.13. Kien hemm suġġeriment li l-palk possibilment għandu jitpoġġa lejn in-naħa t'isfel ħalli ma jkunx hemm interruzzjonijiet minħabba l-quddiesa.
- 5.14. Il-Kunsillier Brincat saħaq li għandna naċċertaw mill-kwalità tal-kantanti għaliex xi wħud ma kinux tal-livell mixtieq.

6. AĠĠORNAMENT TAL-LAQGHA

- 6.1. Qabel ma l-laqqgħa għet fi tmiemha l-Kunsilliera Muscat Fenech Adami infurmat li kellha x-xewqa li tiffurma grupp ta' protezzjoni ċivili tan-Naxxar kif għandhom Mornago. Hija infatti semmiet li diġà ltaqet mad-Direttur tal-Protezzjoni Ċivili li wera dispożizzjoni tad-Dipartiment li jikkollabora biex din l-inizjattiva tirnexxi.
- 6.2. Il-Kunsill qabel ukoll li jorganizza ikla tal-Milied għall-Kunsillieri u l-istaff fid-29 ta' Diċembru. Is-Sindku u s-SE infurmaw li l-Kunsill ma setax ikopri l-*partners* u għalhekk dawn kellhom iħallsu separatament.
- 6.3. Is-SE informa li bejn it-28 ta' Diċembru u l-4 ta' Jannar għandhom jiġu Malta s-Sindku u s-Segretarju tal-Kunsill ta' Mornago.
- 6.4. Il-Kunsill qabel li l-laqqgħa li jmiss issir it-Tlieta 10 ta' Jannar 2011 fis-7:30pm.
- 6.5. Il-laqqgħa għet fi tmiemha fl-21:50pm.
