- 1.3. Il-Kunsillier Sciberras staqsa f'hiex kien wasal punt numru 3.6 dwar l-*outdoor gym*. Is-SE infurma li ma kien hemm l-ebda progress s'issa u għadu qed jistenna mingħand il-Perit.
- 1.4. Il-Viċi Sindku infurmat dwar punt numru 9 (inizjattiva Familja Attiva), li ġiet posposta għar-rebbiegħa minħabba d-diversi attivitajiet, speċjalment dawk relatati ma' attivitajiet internazzjonali f'Malta.

- 2.1. Il-Kunsillier Sammut informa lill-Kunsill li avviċinaw xi residenti ta' Triq San Mark, u kellmuh dwar sit abbandunat fl-istess triq. Huwa qal li r-residenti kellmu s-sid tal-art u talbuh permess biex jirriabilitaw is-sit, biex jiġi bħal ġnien żgħir. Ir-residenti qalu li s-sid tahom il-permess, u saqsew il-Kunsill jistax jipprovdi xi siġar.

- 4.1. Is-Sindku infurmat li min-naħa tas-sottokumitat tal-ilmenti kien ħa deċiżjoni fuq it-talbiet kollha li waslu l-Kunsill.
- 4.2. Il-Kunsillier Sciberras semma l-aħħar ilment tal-lista, dwar tabelli direzzjonali. Kompla billi saqsa jekk dawn humiex konformi mal-Kamra tal-Ispiżjara.
- 4.3. Is-SE qal li l-Kunsill jista jikkomunika mal-Kamra tal-Ispiżjara biex ikun fiċ-ċert li t-tabelli huma konformi.
- 4.4. Il-Kunsillier Sciberras sostna li minħabba li dan il-każ huwa simili ħafna ta' każ fejn it-tabelli ma ġewx aċċettati, liema każ kien li t-tabelli kienu twaħħlu bla permess u l-Kunsill kellu jitleb lis-sid biex jgħamel il-permess, inkella jitneħħew. - 5.2. Is-SE spjega li hemm 10 partners f'dan il-proġett, kollha min pajjiżi differenti. Spjega wkoll li din l-opportunità ġiet minħabba li dan il-proġett ilu biex iseħħ u xi partners oriġinali tilfu l-interess fih.
- 5.3. Il-Viċi Sindku infurmat li fiż-żjara tagħha fi Strumyani kienet milqgħuha tajjeb ħafna u sabet iż-żjara interessanti. Is-Sindku ta' Strumyani kien qiegħed jistieden lill-Kunsill Lokali Naxxar biex jibgħat rappreżentanza bħala grupp folkloristiku minn Malta għall-festival annwali tagħhom. Hija infurmat ukoll li, fl-aħħar elezzjonijiet li saru Strumyani reġa ġie elett l-istess Sindku, Emil Iliev.

- 6.2. Informa ukoll li ma nstabitx akkomodazzjoni għewwa n-Naxxar, għaliex huma kollha fully booked.'
- 6.3. Il-Kunsill qabel ukoll li jstieden lil żewġ rappreżentanti mill-imsieħba fil-proġett Authentic Europe Network biex magħhom jiddiskuti possibiltà ta' proġetti futuri flimkien.
- 6.4. Is-SE kien akkwista stimi għall-akkomodazzjoni li l-irħas instab li kienu mingħand Dolmen għal-prezz ta' €35 kull lejl kull persuna.
