1. APPROVAZZJONI TAL-MINUTI

- 1.1. Ġew imressqa l-minuti tal-laqqgħa numru 38 li kienu meqjusa moqrija.
- 1.2. Fuq proposta tas-Sindku, li kienet issekondata mill-Viċi Sindku, il-Kunsill unanimament qabel li fl-aħħar tas-sentenza ta' qabel tal-aħħar jiżdied il-kliem *'minkejja li dan seta' ġie evitat kieku l-Kunsillier Galea kkomunika magħha biġ-telefon qabel ta l-ordni.'*
- 1.3. F'dan il-ħin waslet il-Kunsilliera Miceli.
- 1.4. Wara konsiderazzjoni l-Kunsill approva b'mod unanimu l-minuti tal-laqqgħa numru 38.
- 1.5. Ġew imbagħad imressqa l-minuti tal-laqqgħa numru 39, laqqgħa imsejja b'urġenza.
- 1.6. Is-SE informa li dwar il-ħatriet ta' skrivani ġodda kellu l-konferma min-naħa tad-Dipartiment li l-Kunsill jista' jimpjega żewġ skrivani mill-istess listi tal-ETC u li kien jinsab fil-proċess tal-għażla.

2. KOMUNIKAZZJONI MIS-SINDKU

- 2.1. Is-Sindku pproponiet li, fid-dawl tal-ħatriet ta' Ministri ġodda, il-Kunsill għandu jibgħat jifirħilhom. Il-Kunsill qabel unanimament.
- 2.2. Il-Viċi Sindku informa li kompli jaħdem fuq il-*website* u anki ddiskuta f'aktar dettall is-sitwazzjoni mal-iżviluppatur tal-istess *website*. Huwa saħaq li sar ħafna xogħol però għad fadal ħafna xogħol ta' informazzjoni li għad trid tidhol li tiegħu ħafna ħin. Informa li,

fl-opinjoni tiegħu, ix-xogħol li kellhom jagħmlu għamluh, u kien jonqos biss l-informazzjoni kollha biex tiddaħħal. Huwa ppropona li l-iżviluppatur ikun mitlub li jagħti taħriġ lill-membri tal-istaff halli jkunu jistgħu jgħinu fix-xogħol iżda fakkar li l-Kunsill ma kien għadu ħallas xejn u għalhekk kien qiegħed jipproponi li, għall-inqas, jithallas nofs li għandu jieħu u n-nofs l-ieħor meta jsir u jitlesta t-taħriġ. Wara diskussjoni l-Kunsill qabel unanimament li jsir kif ippropona l-Viċi Sindku.

- 2.3. F'dan il-ħin (fit-8:23pm) il-Kunsill qabel li jissospendi l-aġenda biex jisma' lill-membri tal-Kunsill Lokali Żgħażaġħ. Informazzjoni dwar dak li kellhom xi jgħidu ż-żgħażaġħ hija annessa f'A.
- 2.4. Il-laqgħa tkomplet fit-8:33pm.

3. RENDIKONTI FINANZJARJI, INFIQ U FWEĠĠĠEĠ OĦRA RELATATI MA' FINANZI

- 3.1. Rapporti Finanzjarji ta' kull Kwart:- Is-SE informa li l-amministrazzjoni, permezz tal-*accountant*, kienet għaddejja bil-preparamenti tal-għeluq tal-kotba għas-sena 2011. Huwa faħħar lill-*accountant* għall-impenn li qed turi tant li, fi żmien relattivament qasir, diġà lestiet ir-rapporti finanzjarji tal-ewwel tliet kwarti tas-sena. Huwa infatti ppreżenta dawn ir-rapporti għall-approvazzjoni tal-Kunsill. Wara konsiderazzjoni l-Kunsill unanimament approva dawn ir-rapporti li jkopru l-perijodi Jannar-Marzu 2011, April-Ġunju 2011 u Lulju-Settembru 2011.
- 3.2. F'dan il-ħin il-Kunsillier Brincat informa li kien hemm problemi bit-tqassim tal-Kuntatt minħabba li allegatament ma tqassamx man-Naxxar kollu. Is-SE informa li kienu diġà waslulu kummenti oħra f'dan is-sens u dwar dan kien qiegħed jindaga bl-għajnuna tal-Kunsillier Sammut.
- 3.3. Il-ħlas tal-kontijiet:- Meta l-Kunsill għadda biex jikkunsidra l-lista ta' pagamenti pendenti l-Kunsillier Brincat ippropona li, sakemm id-Dipartiment itemm l-investigazzjoni li talbu bħala Kunsillieri Laburisti fil-konfront ta' ordnijiet għal servizzi għall-attività tal-Milied li ma kinux approvati qabel mill-Kunsill, m'għandhomx jithallsu l-pagamenti relatati mal-attività ħlief dawk li kienu nkisbu għalihom l-istimi. Partikolarment dawn kienu jinkludu dawk li fil-lista huma nnumerati 24,43,44,86 u 90. Il-Kunsillier Galea ssekonda. Meta tiegħed il-vot din il-mozzjoni m'għaddietx (b'erba' voti favur u erbgħa kontra) u għalhekk il-Kunsill qabel li japprova l-lista kif ipprezentata. Il-lista kompluta hija annessa f'B.
- 3.4. Il-Kunsillier Brincat imbagħad wera x-xewqa li għal laqgħa oħra l-ispejjeż relatati mal-attività tal-Milied ikunu sseparati mill-kontijiet l-oħra.
- 3.5. Sadanittant il-Kunsill talab lis-SE biex jistaqsi lid-Dipartiment dwar l-eżitu tal-investigazzjoni biex kemm jista' jkun jithaffef il-proċess.
- 3.6. Ir-rendikont tad-dħul:- Il-Kunsill approva b'mod unanimu r-rendikont tad-dħul għax-xahar ta' Diċembru 2011. Din hija annessa f'Ċ.
- 3.7. Il-lista ta' ordnijiet:- Is-SE ressaq il-lista ta' ordnijiet għal Diċembru 2011. Il-Kunsilliera Miceli esprimiet li r-rata taż-Zumba tidher għolja. Il-Kunsillier Sammut aċċertaha li dak huwa prezz favorevoli ħafna u infatti huwa irħas minn dak offrut mill-Kunsill Malti għall-Isports liema prezz kien jinsab mal-applikazzjoni għall-iskema sportiva. Il-Kunsilliera Miceli semmiet ukoll li għal darba oħra jkun aktar faċli u prattiku jekk għall-ikla tal-anzjani jintuża materjal *disposable* minħabba li l-għajjutanti kienu impenjati b'wisq xogħol ta' ħasil. Is-SE informa li l-ikla ħalliet bilanċ għall-Kunsill. Din il-lista imbagħad kienet approvata *nem con* (kopja annessa f'D).
- 3.8. Performance bonus għall-impjegati:- Meta l-Kunsill għadda biex jikkunsidra l-*performance bonus* għall-impjegati kien hemm qbil unanimu li l-ħaddiema kollha kienu

qed jaqdu dmirhom bl-aħjar mod possibbli u li ħafna drabi jagħmlu aktar milli wieħed jistenna. Il-Kunsill għalhekk approva li l-impjegati kollha jieħdu l-massimu tal-*performance bonus*.

- 3.9. Offerti u kwotazzjonijiet:- Is-SE informa li fil-ġranet li ġejjin se jipprepara d-dokumenti għall-offerti u/jew kwotazzjonijiet skont il-każ għal dawk is-servizzi li waslu biex jiskadu jew oħrajn ġodda, bħal dawk għall-korsijiet, biex il-Kunsill ikun dejjem konformi mar-regolamenti finanzjarji. Il-Kunsilliera Miceli ssuġġeriet li l-Kunsill għandu jirrikonsidra l-ftehim ma' TCTC minħabba li jkollha xi kummenti min-nies li t-tagħlim mhux ta' kwalità, mhux strutturat u xi drabi l-partecipanti żgħar jaħsbu li se jkollhom korsijiet fuq il-kompjuter u jsibu mod ieħor. Is-SE irrakkomanda li, qabel ma wieħed jieħu xi passi, għandha ssir verifika billi possibilmint, il-Kunsilliera Miceli stess, bħala l-persuna responsabbli mill-edukazzjoni, tattendi għal sessjonijiet tat-tagħlim biex taċċerta ruħha minn dak li semgħet. Dan għaliex ikun hemm ħafna kummenti oħra pożittivi u għalhekk tajjeb li l-Kunsill stess ikun għamel l-evalwazzjonijiet tiegħu. F'dan ir-rigward kien hemm qbil li l-Kunsilliera Miceli għandha tingħata d-dettalji tal-ħinijiet u l-ġranet tal-korsijiet biex tkun tista' tagħmel l-evalwazzjoni.

4. RAPPORTI MILL-KUMITATI/SOTTOKUMITATI

- 4.1. Il-Kunsillier Clinton Sammut ta rendikont tal-ħidma fir-responsabbiltà tiegħu. Huwa semma' li matul is-sena l-oħra ġew organizzati 32 kors, 330 siegħa ta' sports u ħadu sehem 450 partecipant. Informa li l-kummenti li kellu mill-partecipanti kienu pożittivi ħafna. Il-Kunsillier Sammut informa wkoll li, bil-mod kif ġew ipplanati u mħaddma l-korsijiet il-Kunsill seta' jattrezza f'aktar apparat fosthom is-sistema tas-sound. Informa wkoll li, grazzi għall-ħidma li għamel flimkien mas-SE innoxelhom jiksbi rati għall-*instructors* aktar vantaġġużi minn dawk li joffri l-Kunsill Malti għall-Isports u għalhekk il-Kunsill għamel gwadann. Huwa ppropona li l-Kunsill jibgħat jirringrazzja lill-partecipanti, inklużi l-għaqdiet li taw sehemhom.
- 4.2. Il-Kunsillier Sammut informa li, permezz tal-applikazzjoni għal din is-sena, il-Kunsill kien se jorganizza aktar sports u li minnhom se jkomplu jgawdu aktar residenti. Informa li t-total ta' investiment se jaqbeż it-€8,000 u li nofshom għandhom jiġu mill-iskema u l-kumplement ikunu ffinanzjati mill-miżati tal-partecipanti. Huwa semma' li qed jippjana 19-il tip ta' sports differenti. Minħabba restrizzjoni ta' spazju l-Kunsillier Sammut ippropona li l-Kunsill għandu joħroġ sejha għall-kiri ta' post (sala/garaxx) li jakkomoda bejn 35 u 40 partecipant. Il-Kunsill qabel ma' din il-proposta u li possibilmint jintalab prezz bir-rata kull siegħa użu. Il-Kunsill qabel ukoll li jkun stampat fuljett li jinforma bl-attivitajiet sportivi. Intalab però li l-fuljett għandu jinkludi wkoll avviżi oħrajn, fosthom għall-iffurmar ta' sezzjoni tal-protezzjoni ċivili lokali. Kien hemm qbil ukoll li fil-każ ta' korsijiet ta' *first aid* u oħrajn relatati ma' xogħol marbut ma' protezzjoni ċivili, għandha ssir kollaborazzjoni mal-Kunsilliera Muscat Fenech Adami. Il-Kunsillier Sammut informa li reġa' rnexxielu jikseb *vouchers* mingħand TipTop għall-partecipanti. Il-Kunsillier Sammut informa li għall-korsijiet tal-*first aid* l-iscouts kienu qed joffru l-isparju għal ħlas minimu ta' €3 kull persuna.
- 4.3. Dwar il-qasam taż-żgħażaġh il-Kunsillier Sammut informa li kellu kuntatti mal-Imtarfa Drama Group li kienu lesti li joffru korsijiet tad-drama għall-etajiet ta' bejn il-5 u t-12-il sena. Dawn jinvolvu korsijiet fuq 20 sessjoni flimkien ma' reċta fl-aħħar. Il-prezz għall-kull partecipant ikun ta' €40 u jsiru kull nhar ta' Ġimgħa bejn is-6:30 u t-8pm. Min se jgħalliem talab €35 għal kull partecipant. Is-SE hawnhekk talab li l-Kunsill jikkunsidra li eventwalment ikun hemm il-ħtieġa ta' spazju fejn jinżammu l-props u materjal ieħor

konness mar-reċtar. Il-Kunsill laqa' l-proposta tal-Kunsillier Sammut u kien hemm qbil li jinħarġu l-avviżi biex possibbilment l-ewwel laqgħa ssir fl-20 ta' Jannar. Il-Kunsillier Sammut ippropona li l-Kunsill jinkludi l-Għaġġur fl-avviżi iżda l-Kunsill ma qabilx. Kien hemm qbil ukoll li jinħareġ il-flyer tal-Kunsill Lokali Żgħażaġh b'messaġġ żgħir mingħandhom.

- 4.4. Il-Kunsillier Sammut informa li meta sar il-motorsport festival kien hemm problema ta' aċċess għar-residenti tal-Magħtab u li ħass li dan kien kaġun l-aktar minħabba l-istat li tinsab fih it-telgħa li tagħti għall-Għaġġur. Huwa għalhekk ippropona li l-Kunsill għandu jirrangaha. Is-Sindku infurmat li dik kellha tiġi rrangata minn Wasteserv.
- 4.5. Il-Kunsillier Sammut semma' l-inċidenti frekwenti li kien qiegħed ikun hemm fi Triq is-Salina fin-naħa tad-daħla Ta' Saveria. Il-Kunsill qabel li tinkiteb ittra lil Transport Malta. Il-Kunsillier Galea f'dan il-ħin oġġezzjona għall-fatt li l-Kunsillier Sammut ħa wisq ħin biex ippreżenta r-rapporti tiegħu u li dan tal-aħħar kien ilment u ma kellux ikun imressaq f'dan il-ħin.
- 4.6. Il-Kunsillier Sammut informa li kien avviċinat mill-iscouts dwar reċta għall-Ġimgħa l-Kbira bl-isem *Jesus Christ Superstar*. Madanakollu saret oġġezzjoni li kien *out of order* u l-Kunsill għalhekk talab biex jieqaf.

5. TALBA GĦAL TIBDIL FL-ORDNI TAL-AĠENDA

- 5.1. F'dan il-ħin il-Kunsillier Galea ippropona li tinbidel l-ordni tal-laqgħa biex il-Kunsill immedjatament jiddiskuti s-suġġett numru 8 fuq l-aġenda. Il-Kunsill però ma qabilx minħabba li ma ħassx li dan is-suġġett kien ta' urġenza.

Infurmat ukoll li l-pjan kien li l-ġnien ikun inawgurat fit-22 ta' Jannar iżda ma kellha xejn ikkonfermat.

Talent show: Il-membri żgħażaġh infurmaw li kienu qed jiddiskutu l-ħsieb li jorganizzaw *talent show* bl-involvement tal-għaqdiet lokali u żgħażaġh oħra.
