#### 1. APOLOĠIJI

- 1.1. Is-SE informa li l-Kunsillier Sammut kien infurmah bil-kitba li hemm ċans li ma jlaħhaqx jiġi għal-laqqgħa tal-Kunsill (kopja tal-email annessa f'A).
- 1.2. Is-SE informa wkoll li l-Kunsillieri Gatt u Cuomo kienu infurmawh li se jaslu tard.
- 1.3. Is-SE ġibed l-attenzjoni li, skont il-liġi, kull Kunsillier li ma jkunx se jattendi għal-laqqgħa tal-Kunsill għandu mhux biss jibgħat jinfurmah bil-kitba, iżda għandu jagħti r-raġuni għal dan in-nuqqas. B'dan il-mod biss il-Kunsill seta' jkun f'pożizzjoni li jiġġustifika t-tali nuqqas.
- 1.4. Minkejja li ma ngħatatx raġuni għan-nuqqas il-Kunsill qabel li, għal din id-darba, jiġġustifika n-nuqqas tal-Kunsillier Sammut iżda fil-futur kull nuqqas ta' attendenza mill-Kunsillieri għandu jkollu r-raġuni kif titlob il-liġi.

#### 2. XOGĦOL PENDENTI MIL-LAQGĦA PREĊEDENTI

- 2.1. Is-SE informa li kien għad fadal xogħol mil-laqqgħa preċedenti dwar proposta mill-Kunsillier Sammut għat-tindif ta' siti storiċi u l-aċċess tagħhom. Il-Kunsill qabel li dan is-suġġett jaġġornah għal-laqqgħa li jmiss.

### 3. APPROVAZZJONI TAL-MINUTI

- 3.1. Is-SE ippreżenta l-minuti tal-laqqgħa ta' qabel li kienu meqjusa moqrija.
- 3.2. Wara kunsiderazzjoni l-minuti kienu approvati *nem con* u ffirmati mis-Sindku u mis-Segretarju Eżekuttiv (SE).
- 3.3. F'dan il-ħin wasal il-Kunsillier Gatt.
- 3.4. Il-Kunsillier Miceli talbet informazzjoni dwar il-korsijiet għan-nisa li kienu approvati fil-laqqgħa preċedenti minħabba li ma kinitx preżenti. Is-Sindku infurmata li dawk kienu laqqgħat ta' interess għan-nisa u li jistgħu jinkludu s-sugġetti tas-saħħa, *weight loss* eċċ. Issemma li possibilmment dawn għandhom jibdwu f'Ġunju.
- 3.5. F'dan il-ħin waslet il-Kunsillier Cuomo.
- 3.6. Il-Kunsillier Gatt staqsa x'inhi l-pożizzjoni dwar toroq li għandhom 80% jew aktar ta' ħsara u jekk kellux imur il-Perit tal-Kunsill biex jagħmel l-istimi tat-toroq tal-Magħtab. Is-SE informa li l-qbil kien li l-ewwel kellhom iġibu l-lista ta' prioritajiet l-Assoċjazzjoni tal-Magħtab. Isemmev ukoll it-trakkijiet li jidhru fil-Magħtab filwaqt li s-Sindku u s-SE infurmaw li, mil-laqqgħa li kienet saret ma' Wasteserv fil-preżenza tal-Assoċjazzjoni tal-Magħtab, ħareġ ċar li l-problemi ma kinux limitat biss għall-*iscammels* iżda wkoll għat-trakkijiet tal-kostruzzjoni. F'dak il-ħin tal-laqqgħa msemija kien hemm qbil li kellha tkun l-Assoċjazzjoni li tiddetermina x'tip ta' tabelli u restrizzjonijiet trid. Għalhekk f'dan l-istadju l-Kunsill kien qiegħed jistenna mingħand l-Assoċjazzjoni.
- 3.7. Kien hemm qbil unanimu li, meta jitlestew il-minuti ta' dik il-laqqgħa ma' Wasteserv għandhom jintbagħatu lir-residenti tal-Magħtab.
- 3.8. Il-Kunsillier Galea informa li, dwar il-korsijiet li kien ippropona dwar l-istorja tan-Naxxar kien iltaqa' mas-Sinjuri Paul Catania u Victor Scerri fejn tawh il-parir li l-aħjar żmien ikun għall-ħabta ta' Ottubru, meta jibdwu l-iskejjel.
- 3.9. Il-Kunsillier Cuomo esprimet ix-xewqa li fuq il-minuti jkun indikat li hija mhux biss Kunsilliera iżda wkoll ir-rappreżentanta ta' Baħar iċ-Ċagħaq. Il-Kunsill qabel.

### 4. KOMUNIKAZZJONIJIET/KORRISPONDENZA

- 4.1. Il-Kunsillier Galea informa li membri mill-każin Peace kienu rringrazzjaw lill-Kunsill talli laqa' t-talb u għamel *motor cycle* bays quddiem il-każin.
- 4.2. Il-Kunsillier Galea informa li kellu talbiet biex isir parkeġġ ieħor għall-persuni b'diżabilità fil-Pjazza. Madanakollu, minħabba li diġà hemm waħda fl-akwati, il-Kunsill ma qabilx li għandha ssir oħra.
- 4.3. Is-SE irrefera lill-Kunsill għaċ-ċirkulari mill-AKL dwar ix-xogħol tal-Korporazzjoni għas-Servizzi tal-Ilma (KSI). Wara diskussjoni l-Kunsill qabel li, biex ikun jista' jieħu deċiżjoni kellhom jingħataw informazzjoni dettaljata dwar iż-żmien li jieħdu biex iwettqu x-xogħol kif ukoll dwar l-istandards mistennija.
- 4.4. Is-Sindku infurmat li l-Fondazzjoni Azzjoni Lokali tal-Majjistral (MAGF) kienet qed tfejji biex issejjaħ laqqgħa ġenerali skont kif jitlob l-istatut tal-Fondazzjoni. Hija fakkret li l-Kunsill Lokali Naxxar kien rappreżentat fuq il-Kumitat tat-teħid tad-deċiżjonijiet permezz tas-Sur Salvu Sciberras. Hija infurmat li l-Kunsill issa kellu jiddeċiedi jekk għandux juri interess biex jibqa' rappreżentat. Il-Kunsill qabel li l-

Kunsill għandu jipproponi li jzomm postu jew, jekk ma jkunx hemm qbil fost il-membri tal-Kumitat, jiffa' n-nomina għall-elezzjoni.

- 4.5. Is-Sindku infurmat li hi u l-Kunsillier Miceli kellhom laqgħa mas-Sur Ray Abela ta' TCTC dwar il-programm iKids. Filwaqt li s-Sindku tat rendikont tal-laqgħa, is-Sinjura Miceli infurmat li kienet sodisfatta bil-mod kif kien ippjanat il-programm. Il-Kunsill għalhekk qabel li jipparteċipa f'dan il-programm bi spiza ta' €1,100.
- 4.6. Il-Kunsill kien infurmat li l-amministrazzjoni ta' Palazzo Parisio kienu installaw tabelli ta' direzzjoni lejn il-Palazz. Dawn saru bi spejjeż tagħhom stess.
- 4.7. F'dan il-ħin issemma li fiż-żmien kien hemm tabella bl-informazzjoni dwar il-Palazz u m'għadiex hemm. Is-SE fakkar li fil-preżent hemm l-offerti miftuħin għat-tabelli informattivi bħala parti mill-proġett taħt il-miżura 313.
- 4.8. F'dan il-ħin is-SE informa li kien attenda seminar dwar il-*Green Public Procurement*. Huwa spjega li l-kuntratti, qabel ma toħroġ kull offerta, jkunu jridu jgħaddu għall-konferma tat-Taqsima tat-Turiżmu u Żvilupp Sostenibbli.
- 4.9. Is-SE informa li, dwar l-ilment li kien tressaq lid-Dipartiment dwar allegat xiri ta' servizzi għall-attività tal-Milied mingħajr approvazzjoni tal-Kunsill, id-Dipartiment kien informa li ma sab l-ebda nuqqas mill-Kunsill. Il-Kunsillier Brincat informa li kien se jerġa jilmenta mad-Dipartiment.
- 4.10. Is-Sindku infurmat li kellha laqgħa ma' uffiċjali ta' Transport Malta (TM) fejn infurmawha dwar ir-reviżjoni tar-rotot tat-trasport pubbliku. Issa t-trasport kien se jkun rivedut b'mod li jitnaqqsu rotot li mhux qed ikunu utilizzati filwaqt li se jżidu t-trasport fi Vjal il-21 ta' Settembru filwaqt li se jkun hemm servizz fi Triq San Pawl u l-Bye Pass ta' Birguma.

- 7.3. Meta kien diskuss x'tip ta' sigar jithawwlu jekk imutu, inkluż dik ta' Vjal il-21 ta' Settembru, kien hemm qbil li għandhom jithawwlu l-istess tip ta' sigar tal-akbar daqs possibli.
