#### 1. APOLOĠIJI

- 2.8. Il-minuti tal-laqqgħa numru 41 u tal-laqqgħa b'urgenza ġew approvati u ffirmati mis-Sindku u mis-SE.

- 3.2. Il-Viċi Sindku staqsiet jekk konsultazzjoni mar-residenti dwar punt numru 9 saritx, u jekk intbagħtix korrispondenza lil-TM kif kien deċiz f'punt numru 10. Is-SE ikkonferma li sar dan.

### **5. KOMUNIKAZZJONI MIS-SINDKU U KORRISPONDENZA**

- 5.1. Is-SE fakkar il-Kunsill fil-Laqqgħa tal-Lokalità, li se ssir nhar it-Tlieta 15 ta' Marzu 2016.
- 5.2. Is-SE informa lill-Kunsill li nhar il-Ħamis 25 u l-Ġimgħa 26 ta' Frar 2016 għandu jsir xogħol ta' traqqiegħ maġġuri fi Vjal il-21 ta' Settembru, li possibilment hemm ċans li jkompli wkoll is-Sibt 27 ta' Frar.
- 5.3. Is-SE informa li l-ispiza ġiet oġhla minn dik li kien ikkalkula l-Perit minhabba li deherlu li kellu jżid ix-xogħol minhabba la ma ħassx li jista' jsir xogħol u ma jkunx komplut jew jithallew ħsarat. Is-SE informa li l-ispiza hija ta' ċirka €62,000. Il-Kunsill qabel.
- 5.4. Il-Kunsillier Cuomo infurmat li l-Laqqgħa tal-Komunità ta' Baħar iċ-Ċagħaq se ssir fl-ewwel ġimgħa ta' Mejju.
- 5.5. Is-Sindku infurmat li ġew assenjati żewġ ħaddiema tal-IPSL lir-Reġjun. Komplet tispjega li dawn iridu jimlew rapport ta' ħidma kuljum, u jiffirmaw filgħodu x'ħin jidhlu għax-xogħol u filgħaxija x'ħin ilestu.
- 5.6. Is-Sindku infurmat ukoll li dawn il-ħaddiema se jkun qed ikunu assenjati lil kull Kunsill tar-reġjun għal xahar, u l-ewwel Kunsill li se jibbenefika minnhom huwa propju il-Kunsill tan-Naxxar u wara l-Kunsill ta' Pembroke, minhabba li m'għandhomx ħaddiema tal-IPSL permanenti assenjati magħhom.

- 5.7. Is-Sindku infurmat li l-proġett intitolat eMCitizen Project tat-TCTC se jkun qed japplika għalih ir-Reġjun, u minhabba f'hekk il-Kunsilli kollha tar-reġjun ikunu jistgħu jibbenefikaw minnha b'xejn.

## **6. HLAS TA' KONTIJET, RENDIKONTI FINANZJARJI U INFIQ**

- 6.1. Il-Kunsill approva l-lista ta' pagamenti kif annessa f'B.
- 6.2. Il-Kunsill approva ukoll il-listi ta' dħul u infiq, kif annessi f'Ċ u D rispettivament.
- 6.3. Il-Viċi Sindku talbet li fl-aġenda li jmiss jiddaħħal is-suġġett tal-fuljett tal-Kunsill Il-Kuntatt.

## **7. PROPOSTA TA' TWESSIEGH TA' TRIQ IL-FORĠA**

- 7.1. Il-Kunsillier Gatt informa li peress li f'din il-proposta hemm involuti għelieqi, li waħda minnhom hija tal-familja tiegħu, iħoss li għandu joħroġ mill-laqqgħa minhabba possibiltà ta' kunflitt ta' interess. Għalhekk il-Kunsillier Gatt skuża ruħu mil-laqqgħa sakemm jiġi diskuss dan il-punt.
- 7.2. Is-SE ippreżenta l-proposta li rċieva l-Kunsill mingħand is-Sur Angelo Xuereb biex jiġu mwessgħin xi partijiet minn Triq il-Forġa. Din il-proposta hija maħsuba biex tnaqqas il-periklu hekk kif qed jiżdied l-influss tat-traffiku fiha, speċjalment issa li hemm dar tax-xjuħ fl-istess triq. Parti mill-proposta tinkludi li titwessa parti mit-telgħa tal-iskejjel sabiex issir parkeġġ għat-trasport tal-iskejjel. B'dan il-mod jitnaqqas it-traffiku miċ-ċentru minhabba li ħafna minnu jgħaddi mill-periferija.
- 7.3. Is-SE spjega li t-talba ma' din il-proposta hija biex il-Kunsill jagħmel pressjoni ma' TM u l-Gvern Ċentrali biex isiru l-arranġamenti skond il-proposta.
- 7.4. Wara diskussjoni, il-Kunsill qabel li għandu jibgħat din il-proposta lill-awtoritajiet konċernati.

## **8. IL-BAĠIT U L-PJAN**

- 8.1. Is-Sindku sostniet li Triq Santa Marija għandha tingħata priorità biex issir mill-ġdid, minhabba l-istat ta' tagħha.
- 8.2. Il-Kunsillier Brincat esprima li din it-triq m'għandiex tingħata daqshekk importanza u kien aktar jagħmel ġid jekk tittella' aktar il-fuq Triq il-Markiz Scicluna. Huwa qal li din it-triq għandha bżonn akbar ta' tiswija u m'għandniex ingħibu skuża li m'għandniex biżżejjed fondi. Is-Sur Brincat sostna li dan qed jiġri wkoll fil-każ tal-ilmenti li l-Kunsill dejjem jgħid li m'hemmx fondi iżda meta tasal elezzjoni l-flus jinstabu u jkunu solvuti ħafna ilmenti. L-ilmenti għandhom jingħataw dejjem l-istess priorità tul is-sena kollha u mhux meta tasal l-elezzjoni, sahaq is-Sur Brincat.
- 8.3. Filwaqt li diversi Kunsilliera esprimew l-opinjoni tagħhom, wara diskussjoni kien hemm il-qbil li t-toroq għandhom isiru skond il-lista li kienet diġà approvata mill-Kunsill fi Frar 2015 bl-eċċezzjoni ta' Vjal il-21 ta' Settembru li f'laqgħat suċċessivi kien hemm qbil li titla' fl-ewwel post.
- 8.4. Is-SE ippreżenta abbozz tal-Baġit u spjega li dan għandu jiġi approvat wara l-laqqgħa tal-lokalità halli jekk jittersaq suġġeriment ta' interess ikun jista' jiġi inkluz. Sahaq li dan huwa biss abbozz u li għad irid jidhol fid-dettall fih u kif ikun qrib lejn il-finali, jgħaddilhom kopja.
- 8.5. Is-SE ippreżenta wkoll ir-rapport finanzjarju tal-kwart Ottubru – Diċembru 2015 iżda informa li dan kien qiegħed jipprezentah kif irċevih ftit qabel mill-accountant. Infatti huwa seta' jinnota xi figuri li ma kienx qiegħed jaqbel magħhom.

8.6. Il-Kunsill qabel li jiċċara dawn il-figuri imbagħad ikun jista' japprovah.
