1. APPOLOĠIJI

- 1.1. Is-Segretarju Eżekuttiv (SE) avża li l-Kunsillier Galea kien infurmah li se jasal tard.
- 1.2. Is-SE informa wkoll li f'tit ħin qabel il-laqqgħa kien irċieva sms mingħand il-Kunsillieri Miceli u Sammut li infurmawh li inqabdu xogħol u l-università rispettivament u ma kienx possibli li jibgħatu email fil-ħin. Il-Kunsill qabel li jaċċetta jekk jibgħatu *email* wara u jispjegaw ir-raġuni wara n-nuqqas ta' *attendenza*. Dawn l-*emails* ikunu jistgħu jiġu meħmuża ma' dawn il-minuti.

2. APPROVAZZJONI TAL-MINUTI

- 2.1. Is-SE ippreżenta l-minuti tal-laqqgħa numru 53.
- 2.2. Is-Sindku ressqet emenda biex, bejn l-ewwel u t-tieni sentenza tal-paragrafu numru 10.3 jiddaħħal dan il-kliem: "*Dan sabiex nużaw aktar enerġija nadifa u fl-istess ħin innaqqsu l-carbon footprint u l-ispejjeż tal-manutenzjoni u l-konsum tad-dawl. Huwa stmat li kemm il-konsum u anki l-manutenzjoni jonqsu b'50%.*"
- 2.3. Wara kunsiderazzjoni l-minuti kienu approvati *nem con* kif emendati u għalhekk iffirmati mis-Sindku u mis-SE.

- 2.4. Il-Kunsilliera Muscat Fenech Adami staqsiet x'kien l-iżvilupp dwar para. 6.3 dwar il-*bins* fejn is-SE informa li, kif kien maqbul mill-maġġoranza tal-Kunsillieri, wara li ma kinux instabu *litter bins* adegwati għall-prezz indikat mill-Kunsill fil-laqgħa preċedenti, issa kienu qed ifittxu *litter bins* ta' valur ogħla, ċoè ta' madwar €200. Però sa issa ma kellux informazzjoni x'jista' jgħaddi lill-Kunsill.
- 2.5. Il-Kunsillier Muscat Fenech Adami staqsiet jekk kienx hemm xi żviluppi fir-rigward tal-*belvedere* fejn is-SE wieġeb fin-negattiv.
- 2.6. Il-Kunsillier Muscat Fenech Adami irrimarkat dwar l-istat tal-*bring-in site* ta' Triq L-Imdina u talbet biex tingibed l-attenzjoni tal-kuntratturi dwarhom.
- 2.7. Is-Sindku rreferiet għall-para. 10.3 fejn infurmat li kienet gābet l-informazzjoni u li permezz tagħhom tista' ssir l-applikazzjoni taħt l-aħħar skema għal inizjattivi speċjali. Hija infurmat li l-proposta li għaddewla kienet li jinbidlu l-bozoz u l-*lamp head* għal oħrajn LED's u li għandhom 25 sena garanzija. Is-SE informa li kellu l-obbligu li jinforma li numru mdaqqas ta' bozoz li fuqhom qed ikun propost li jsir l-investment preżentament jinsabu fir-responsabbiltà tal-Enemalta iżda, kemm-il darba jsir ix-xogħol dan ikun ifisser li se jaqgħu f'idejn il-Kunsill Lokali, inkluż il-manutenzjoni. Ingibdet l-attenzjoni wkoll li wieħed irid joqgħod attent għall-istat tal-arbli. Kien hemm qbil unanimu li s-Sindku u l-Kunsillier Brincat jeżaminaw l-arbli ta' Vjal il-21 ta' Settembru biex jaraw l-istat tal-arbli. Jekk b'mod ġenerali jkunu tajbin is-SE imexxi bl-applikazzjoni. Is-SE informa li l-proposta tlaħħaq is-somma ta' €20,709 u li jekk jinkisbu l-fondi, nofshom irid joħroġhom il-Kunsill.

3. KOMUNIKAZZJONIJIET

- 3.1. Il-SE informa li kienet waslet korrispondenza mingħand il-Ministeru tas-Saħħa dwar open day li se ssir fil-Ministeru u li matul dan il-jum wieħed ikun jista' jagħmel eżamijiet mediċi b'xejn. Fl-ittra kien qiegħed ikun mistoqsi jekk il-Kunsill jixtieqx jorganizza t-trasport għal gruppi min-Naxxar.
- 3.2. F'dan il-ħin wasal il-Kunsillier Galea.
- 3.3. Is-Sindku pproponiet li l-Kunsill jipprovdi t-trasport biex jieħu l-anzjani tad-day centre. Il-Kunsill qabel.
- 3.4. Is-SE informa li kienet waslet korrispondenza mingħand ċertu Daniel Vella li kien qiegħed jipproponi lill-Kunsill biex jikkonsidra *bye law* kontra l-ħmieġ taż-żwiemel u b'mod partikulari biex ma jithallewx jgħaddu żwiemel minn ċertu toroq. Il-Kunsill b'mod unanimu ddikjara li jaqbel fil-prinċipju għaliex ilu pre-okkupat mill-ħmieġ taż-żwiemel iżda ma jidhirx li *bye law* hija soluzzjoni Prattika għal diversi raġunijiet, fosthom il-fatt li numru ta' residenti għandhom iż-żwiemel fir-residenzi tagħhom filwaqt li diffiċli ħafna li wieħed jikkontrolla.
- 3.5. Is-SE informa li kienet waslitlu talba mingħand sid iċ-ċirklu biex jagħmel parata bil-ġmula fit-toroq tan-Naxxar.
- 3.6. Il-Viċi Sindku saħaq li iċ-ċirklu kien ilu aktar minn 30 ġurnata u għalhekk, la darba aktarx ma kienx qiegħed bil-permessi meħtieġa, il-Kunsill kellu jinsisti li l-MEPA tinforza. F'dan il-ħin kien diskuss x'tip ta' komunikazzjoni għandha tintbagħat lill-MEPA mingħajr ma l-Kunsill ikun sugġett għal xi passi għal danni fil-konfront tiegħu. Kien qiegħed ikun propost li l-Kunsill għandu jibgħat jistaqsi lill-MEPA dwar jekk, wara li għaddew it-tletin jum, il-

MEPA kinitx f'arġet xi permessi u jekk le x'passi se jittieħdu fil-konfront taċ-ċirklu.

- 3.7. Is-Sindku pproponiet li l-Kunsill għandu jsejjaħ lir-residenti biex, flimkien mal-avukat tal-Kunsill, ikun spjegat lilhom is-sitwazzjoni u wara ssir l-ittra lill-MEPA skont il-kummenti tar-residenti. Dan biex ir-residenti jkunu involuti aktar. Madanakollu l-Viċi Sindku sostna li huwa kien qiegħed jirrappreżenta lir-residenti u għalhekk ma kienx hemm għalfejn issir il-laqqgħa, biex ma jinħeliex ħin. Il-Kunsill imbagħad qabel li tintbagħat l-ittra iżda s-Sindku talbet li l-ewwel tressaqha lill-avukat ħalli taċċerta li bl-ebda mod ma tissuġġetta l-Kunsill għal xi forma ta' danni.
- 3.8. Sadanittant il-Kunsill irrifjuta li jawtorizza l-parata mitluba.
- 3.9. Is-SE informa li kienu saru l-arranġamenti meħtieġa biex it-tħawwil ta' siġar u arbuxelli minn FTI AS (Malta) fi Triq San Mark isir is-Sibt 15 ta' Diċembru fid-9am. Kulhadd kien mistieden.
- 3.10. Is-SE informa li l-*Public Contracts Review Board* kien iddeċieda kontra l-offerent li ressaq l-appell kontra l-Kunsill dwar l-offerti għax-xogħol fi Triq Castro. Għaldaqstant il-proċess seta' jtkompla.

4. HLAS TA' KONTIJET U APPROVAZZJONI TA' RENDIKONTI FINANZJARJI

- 4.1. F'dan il-ħin il-Viċi Sindku kien skużat mill-kumpliment tal-laqqgħa. Il-ħin kien it-20:37.
- 4.2. Is-SE ippreżenta l-lista ta' **pagamenti** li kienet mibgħuta qabel il-laqqgħa lil kull Kunsillier. Il-pagamenti skont il-lista kif annessa f'A kienet approvata.
- 4.3. Kienu wkoll imressqa u approvati l-listi tal-ordnijiet u tad-dħul li huma annessi f'B u f'Ċ rispettivament.
- 4.4. Is-SE informa li ġieli jkun hemm il-bżonn li titqabbaż mużika u ma jkunx possibli għaliex fil-Kunsill m'hemmx CD player. Huwa kien indaga u sab wieħed bi prezz ta' €59 mingħand YAL tan-Naxxar. Il-Kunsill qabel li jinx tara.
- 4.5. Is-SE ġibed l-attenzjoni li kienu meħtieġa ftit siġġijiet li jkunu permanenti għall-pubbliku għas-sala tal-konferenzi. Kien hemm qbil li jinx traw tmien siġġijiet suwed.
- 4.6. Il-Kunsillier Muscat Fenech Adami infurmat li kellha talbiet biex ikun irrangat Sqaq il-Palk minħabba li allegatament hemm il-ħofor u meta jgħaddu l-karozzi meta jkun hemm l-ilma fit-triq qed jittajjar l-ilma fuq il-faċċati. Hija infurmat ukoll li kien hemm parti minn Triq il-Forġa li niżlet u li, minkejja li meta l-art tkun niexfa ma tkunx tidher, meta t-triq tkun imxarrba żżomm l-ilma u jittajjar mal-faċċati. Is-SE informa li dwar dan tal-aħħar ilu jkollu ilmenti mingħand is-Sur Salvu Sciberras iżda dejjem kellu d-dilemma x'għandu jsir minħabba li t-triq meta tkun niexfa tidher tajba ħafna. Kien għalhekk li kien jeħtieġ direzzjoni mill-Kunsill. Il-Kunsill qabel li aktar għandu jiffoka fuq toroq imkissrin iżda dawn għandhom jitpoġġew fuq il-lista' li jeħtieġu attenzjoni biex eventwalment il-Kunsill jiddeċiedi fuq il-prijoritajiet.

5. IL-PJAN TA' TLIET SNIN

- 5.1. Is-SE informa li kienu waslulu żewġ risposti oħra u infatti esebixxa kif kien qiegħed jindika r-riżultat skont il-prijoritajiet tal-ħames Kunsillieri. Huwa talab aktar risposti ħalli imbagħad il-Kunsill ikun jista' jiddiskutihom u jasal li japprova lista finali.

6. KORSIJET DWAR L-EMPOWERMENT GHAŻ-ŻGHAŻAGH

- 6.1. Is-SE informa li kienet waslet korrispondenza mill-Aġenzija Żgħażaġh dwar korsijiet tal-Empowerment. Huwa fakkar li l-Kunsill kien diġà approva dawn il-korsijiet iżda l-konkorrenza kienet fqira u kellhom jiġu kkanċellati.
- 6.2. Il-Kunsill qabel li għandu jerga joffri dawn il-korsijiet skont id-domanda li jkun hemm.
- 6.3. Il-Kunsillier Gatt ippropona li dawn isiru bi sħab ma' Navitas tas-Sgħajtar. Il-Kunsill però ma qabilx.

7. VARAR TAL-KTIEB TAR-RITRATTI

- 7.1. Is-SE informa li l-ktieb jinsab għall-istampar filwaqt li l-gimġha ta' qabel saret preżentazzjoni tiegħu u li għaliha l-Kunsillieri kienu mistiedna kollha. Dawk li attendew approvawh. Dan se jkun jismu VV Viva l-Vitorja.
- 7.2. Is-SE wera l-ktieb kif se jkun li intlaqa' tajjeb ħafna.
- 7.3. Il-Kunsill qabel li għandu joffri prezz ta' qabel il-pubblikazzjoni ta' €20 filwaqt li wara ma jkunx jinbiegħ għal inqas minn €25 iżda dwar dan jittieħdu l-pariri meħtieġa minn persuni kompetenti.
- 7.4. Il-Kunsill qabel ukoll li għandha tingħata kopja bla ħlas lill-Kunsillieri kollha, l-istaff tal-Kunsill, ex-Kunsillieri, għaqdiet, mexxeja politiċi u persuna kritiku.
- 7.5. Possibilment il-varar tal-ktieb isir lejn l-aħħar ta' Jannar u għandu jsir tentattiv biex l-okkażjoni ssir f'Palazzo Parisio.
- 7.6. Il-Kunsill qabel li s-SE jippreżenta kotba lis-Sindku ta' Mornago u l-Assessore ta' Varese fi żjara li se jagħmel l-Italja fil-bidu ta' Jannar.
- 7.7. Sadanittant il-Kunsill kien imfakkar li lejn it-tmiem tal-leġislatura normalment jippubblika ktieb dwar il-ħidma f'dik il-leġislatura. Il-Kunsill approva li dan għandu jsir sa qabel tmiem il-leġislatura biex jirrapporta l-erba' snin ħidma tal-Kunsill.

8. L-OFFERTI GĦALL-ĠBIR TA' SKART IMĦALLAT

- 8.1. Is-SE fakkar li l-kuntratt tal-ġbir ta' skart kien skadut u kien se jibda l-proċess għall-ħruġ tal-offerti. Huwa staqsa jekk il-Kunsill jixtieqx xi speċifikazzjonijiet jew kundizzjonijiet godda. Il-Kunsill qabel li jzomm ma' kif inhu fil-preżent.

9. IL-LAQGĦA TAL-LOKALITÀ

- 9.1. Il-Kunsill qabel li l-laqqgħa tal-lokalità ssir it-Tlieta 29 ta' Jannar fis-19:30. Minħabba li aktarx is-SE mhux se jkollu biżżejjed ħin biex jipprepara mhux neċessarju li jsir il-filmat.

10. TMIEM IL-LAQGHA

- 10.1. Qabel ma l-laqqha ġiet fi tmiemha l-Kunsill qabel li l-laqqha li jmiss issir it-Tlieta 22 ta' Jannar 2013. Il-Kunsill kien konxju li kien se jdum aktar milli tippermetti l-liġi biex jiltaqa' madanakollu mhux se jkun possibli li ssir qabel minħabba li s-Sindku u s-SE se jkunu fuq safar uffiċjali tal-Kunsill
- 10.2. Il-laqqha ġiet fi tmiemha fl-21:55.
