#### 2. KUNSIDERAZZJONI U APPROVAZZJONI TAL-MINUTI

- 2.1. Is-SE ippreżenta l-minuti tal-laqqgħa numru 55 li kienu meqjusa moqrija. Is-SE ġibed l-attenzjoni li ma kienx qed jippreżenta l-minuti tal-laqqgħa b'urgenza, iżda se jkun qed jipprezenthom fil-laqqgħa li jmiss.
