1. NUQQAS TA' QUORUM

- 1.1 Il-laqgħa ma setgħetx tibda fil-ħin minħabba li fil-ħin li ssejthet il-laqgħa ma kienx hemm il-*quorum* meħtieġ.

2. QARI TAL-ITTRI TA' APOLOĠIJI

- 2.1. Is-Segretarju Eżekuttiv (SE) informa li l-Viċi Sindku ma setax jattendi minħabba funeral tal-familja.
- 2.2. Is-SE informa ukoll li l-Kunsillier Galea kien infurmah li se jasal tard għall-laqgħa. Kopji tal-emails annessi f'A.

3. KUNSIDERAZZJONI U APPROVAZZJONI TAL-MINUTI

- 3.1. Is-SE ippreżenta l-minuti tal-laqgħa preċedenti, li kienu meqjusa moqrija.
- 3.2. Il-minuti ġew approvati, *nem con*, wara proposta mill-Kunsilliera Cuomo, ssekondata mill-Kunsillier Gatt. Dawn ġew iffirmati mis-Sindku u mis-SE.

- 3.3. Is-SE issuggerixxa li tibda ssir lista wara l-laqqhat tal-Kunsill bid-deċiżjonijiet li ttieħdu u din tinżamm aġġornata bl-informazzjoni ta' x'azzjoni tkun ittieħdet, jekk ikun il-kaz.
- 3.4. Is-SE spjega li l-iskop ta' dan is-suggeriment huwa biex deċiżjonijiet ma jintesewx, il-Kunsilliera jkunu aġġornati bl-andament tax-xogħol il-hin kollu u jitnaqqas l-ammont ta' hin li jittieħed mill-laqqha tal-Kunsill stess b'mistoqsijiet mill-Kunsillieri dwar din l-informazzjoni.
- 3.5. Wara diskussjoni, il-Kunsill qabel li tibda ssir din il-proċedura. Għal-lum, minhabba li s-sistema għadha m'hix mibdija, il-Kunsillieri xorta jistgħu isaqsu xi mistoqsijiet hekk għandhom.
- 3.6. Il-Kunsillier Gatt staqsa dwar punt numru 3.17, rigward il-proġett ta' restawr mill-MTA. Is-Sindku infurmat li għadhom għaddejjin id-diskussjonijiet u għalhekk għad m'hemm xejn ikkonfermat dwar x'għandu jkun restawrat.

Hija infurmat li żammet kuntatt mar-residenti involuti u minhabba l-fatt li kollox kien jindika li kien diffiċli ferm li jinbidel xi haġa bl-appell, huwa aktar għaqli li dawn il-flus jintefqu fuq affarijiet aktar ta' għid għar-residenti milli fuq xi haġa li tkun inutli. Għalhekk kien hemm qbil li l-appell jiġi rtirat.
- 3.8. Hija infurmat li saret laqqha bejn il-kuntrattur u r-residenti, fejn bdew diskussjonijiet biex il-kuntrattur jirranġa parti miż-żona sabiex jiżdied il-parkeġġ fiż-żona u b'hekk jittaffew xi ftit il-problemi li żvilupp bħal dan joħloq lir-residenti.

- 4.9. Wara diskussjoni qasira l-Kunsill qabel li ssir sejha biex jiġi fformat kumitat.
- 4.10. Is-Sindku infurmat li l-Kunsill kien se jieħu sehem fil-European Mobility Week, però minħabba li l-Kunsillieri inkarigati ma setgħux jiddedikaw biżżejjed ħin biex tiġi organizzata l-attività, din kellha tiġi kkanċellata.
- 4.11. Is-SE ħa l-opportunità li jissuġġerixxi li għandu jkun Kunsillier wieħed biss li jkun responsabbli minn attività/inizjattiva tal-Kunsill u jkun hu li jikkomunika ma' Kunsillieri oħra li jkunu jistgħu jassistuh skont ir-responsabbiltà li jkollhom. Il-Kunsill qabel.
