During a meeting held on Friday 18th July, with the Minister for the Economy, Investment and Small Business, Dr. Chris Cardona, the below points were discussed:

1. The White Rocks Malta Expression of Interest includes a planned location analysis which highlights all the ecological and historical sensitive areas on the site. This was specifically done so that those interested can blend their innovative ideas with the environmental aspects, particularly the ecological aspects.
2. Any development will need to adhere to the Natura 2000. However, one should remember that Natura 2000 is not a system of strict nature reserves where all human activities are excluded. The emphasis will be on ensuring that future management is sustainable, both ecologically and economically. The establishment of the network of protected areas also fulfils a Community obligation under the UN Convention on Biological Diversity.

Furthermore, the sustainable development goals must take into consideration the outcome document of the Rio+20, where member States agreed that sustainable development goals:

- Be based on Agenda 21 and the Johannesburg Plan of Implementation
- Fully respect all the Rio Principles
- Be consistent with international law
- Build upon commitments already made
- Contribute to the full implementation of the outcomes of all major summits in the economic, social and environmental fields
- Focus on priority areas for the achievement of sustainable development, being guided by the outcome document
- Address and incorporate, in a balanced way, all three dimensions of sustainable development and their interlinkages
- Be coherent with and integrated into the United Nations development agenda beyond 2015
- Not divert focus or effort from the achievements of the Millennium Development Goals.
- Include active involvement of all relevant stakeholders, as appropriate, in the process

The expression of interest should be seen as an exploration of innovative ideas. However, the parameters or the domain of these innovative ideas must be within the framework of the area identified in the Expression of Interest. So the Government will need to study all the proposals and together with the various stakeholders will seek to find a balanced solution which respects the concepts defined in the 'White Rocks Development Brief, Planning Directorate, MEPA, 1995.'

Furthermore, Dr. Chris Cardona has invited the Pembroke Local Council to appoint a representative to observe all the stages that the Privatization Unit will undertake in order to examine and adjudicate the submitted proposals.

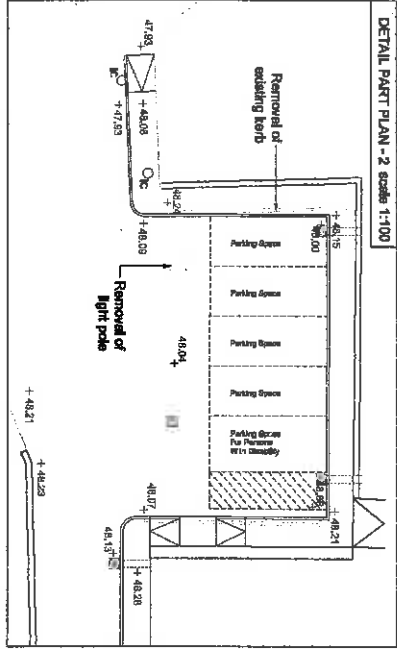


LAYOUT PLAN - scale 1:250

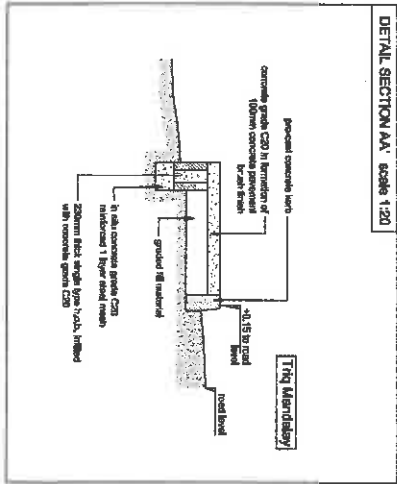
DETAIL PART PLAN - 1 scale 1:100
