

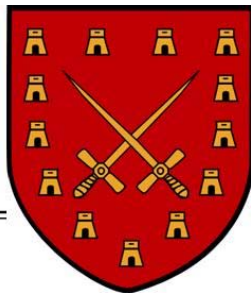

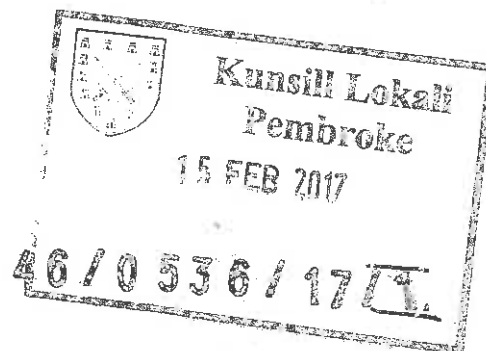

Reference is being made to the Council's letter received on 7th February 2017 regarding the above mentioned works order.

Given that no records of the road works carried out at Triq il- Mediterran are available and the type of defects vary, Cornerstone A&CE suggest the following way forward:

- A thorough condition survey of the whole road, documenting all defects with photos cross referenced with the chainages to identify and differentiate between the different types of defects
- Following the above survey, we shall be able to determine the exact location of 12 sets of three cores along the 1km chainage of the road
- These tests will provide insight on the following properties:
 - Mechanical properties of the aggregate used in the asphalt mixture
 - Mix design characteristics including bitumen constituents
 - Degree of compaction
 - Thickness of road build up



- In addition to the above, we also propose 3 tests to investigate the bearing capacity of the underlying road subgrade including plate bearing test and/or sand replacement test.
