1. QARI U APPROVAZZJONI TAL-MINUTI

Is-Sindku ippropona li l-Minuti tas-Seduta numru 227i u 227ii ikunu approvati bħala dokument korrett.

Il-Kunsillier is-sur Jesmond Tanti issekonda u l-Kunsill qabel b'mod unanimu.

2. PUNTI LI JOHORĠU MILL-MINUTI NRU 227i u 227ii

2.1 Stima ta' Xogħlijiet fi Triq Dr Nikola Zammit u Triq Dun Manwel Zammit

Is-Segretarju Eżekuttiv qal li l-istima tal-perit għal dik li tirrigwardja Triq Dun Manwel Zammit tammonta għal €5,500. Is-Sindku qal li din għandha tkun diskussa meta jkunu diskussi l-estimi finanzjarji tal-2011.

Rigward il-każ ta' Triq Dr Nikola Zammit, is-Segretarju Eżekuttiv qal li l-Perit mar fuq il-post u fl-opinjoni tiegħu ma jirriżultax li fil-post indikat joqgħod xi ilma.

2.2 Roundabout fi Triq Santa Margerita/ Triq Papa Pawlu VI

Is-Segretarju Eżekuttiv qal li kien iltaqa' mal-Perit dwar din il-materja u dan min-naħa tiegħu kellu jlesti l-pjanti u l-applikazzjoni neċessarja.

2.3 Attività tal-Milied

Il-Viċi-Sindku qal li din l-attività kellha titħassar minħabba li diversi persuni fis-sotto-kumitat ma setgħux ikomplu bil-ħidma tagħhom. Madankollu, is-sigra tal-Milied li kellha se ssir xorta waħda fil-pjazza.

2.4 Il-festa tal-Majjal

Il-Kunsillier Joe Sammut qal li wara laqgħa li huwa flimkien mas-Segretarju Eżekuttiv kellu ma' rappreżentant tal-Għaqda tal-Prodotturi tal-Majjal, u rappreżentant tal-Ministeru tal-Biedja, kien iċċarat li l-Kunsill kien mitlub li jkun involut biss fl-arrangamenti tat-traffiku. Dan dejjem jekk ma jkun hemm l-ebda oġġezzjoni min-naħa tal-Kunsill għall-organizzazzjoni ta' din l-attività.

Is-Sindku ippropona li l-Kunsill m'għandu jkollu l-ebda oġġezzjoni għal din l-attività. Il-Kunsillier is-sur Joe Sammut issekonda u l-Kunsill qabel b'mod unanimu.

3. FINANZI

3.1 Pagamenti

Is-Segretarju Eżekuttiv poġġa fuq il-mejda kopja tad-dokument li juri l-lista tal-pagamenti.

Is-Sindku ippropona li l-pagamenti, barra dawk relatati mal-Kumitat Kongunt jiġu approvati kif inhuma.

Il-Kunsillier Dr Mark A. Vassallo issekonda. Il-Kunsill approva b'mod unanimu.

Is-Sindku ressaq għall-vot il-ħlasijiet relatati mal-Kumitat Kongunt. L-eżitu kien:

3.2 Rapport tal-Awditur

Is-Segretarju Eżekuttiv qal li kien wasal ir-rapport tal-Uffiċċju tal-Awditur Ġenerali dwar il-Kunsill. Is-Sindku stieden lis-Segretarju biex jaqra l-parti li tikkonċerna l-Kunsill Lokali Siggiewi.

“Income from LES was not always deposited in the bank account specifically created for contravention deposits but in the Council’s Saving Account. Moreover, reconciliation in respect of LES Income was not being prepared. The Council does not prepare a ‘bank deposit sheet’ which identifies income actually deposited into the bank, as required by the applicable procedures. Consequently, testing on income from LES, as well as that received under General Income, was very limited. In fact, LGA was unable to determine whether such income was deposited intact and on a regular basis.

“The Council is effectively part of the Central Joint Committee and such reporting is conducted by the same organization. Hence the Council is not able to reconcile all Income and Receivables under this system.

“On request, the Council distributes mobile top-up cards to its members, as reimbursement of mobile call expenditure that is deemed to have been incurred in the performance of Council-related duties. No reimbursement claim forms are being filled by the person receiving the reimbursement. Furthermore, the Council provides the Mayor and the Executive Secretary with a fixed mobile plan, paid entirely by the Council.

“This procedure has been immediately rectified and all reimbursements to the Mayor and Councillor’s have been stopped to reflect the direction coming from the DLG.

“The Council is not recognizing LES Payables representing paid contraventions where the place of incident is not Siggiewi, and which have not been remitted to the respective Local Councils by the end of the year. Failure to recognize such amounts is not giving a clear picture of the amounts owed by the Council as at 31st December 2009.

“Unrecorded transactions in both the payables list and Nominal Ledger resulted in an unreconciled net difference of € 9,335.

“The Council cannot understand how LGA arrived to this difference since from its record, the balance of payables within the Trial Balance amounts to €128,412 and the balance within the aged payables reports for the same period give the same balance.

“The Council did not provide any disclosures for its capital commitments in the Financial Statements, which are anticipated to include €115,000 relating to Road Resurfacing and €100,000 to Improvements to Property.

"The Council did not submit a reply.

"A significant expenditure of €4,361 per annum is being incurred by the Council to finance a Health Insurance Scheme for six members of the Council, the Executive Secretary and two clerks.

"The Council has been following the procedure for nearly ten years and was never informed that it was breaking any rules or procedures.

"The Council issued a call for tenders for maintenance and construction of pavements. The tender was awarded to a contractor who had already carried out works for the Council, on the basis that this offer was the second cheapest and the quality of work had always been satisfactory. Furthermore, the performance bond as specifically requested by the applicable rules has not been extended. LGA recommended that the Council should terminate the contract with the supplier so that it complies with the relevant Local Councils procedures.

"This particular contractor was advised several times, both verbally and in writing, and following his non-compliance, the Council terminated the contract and issued another tender, weeks before the publication of the Auditor's Report."

Is-Segretarju Eżekuttiv qal li l-kummenti ta' dan ir-rapport l-aktar l-aktar li jikkonċernaw huwa l-ħlasijiet tal-*Local Enforcement System*, hu kif jgħid l-istess rapport ma jithaddmux mill-Kunsill imma mill-Kumitat Kongunt, u għal din ir-raġun ma nistgħux, kif inhi s-sistema preżenti nirrikonċiljaw kull *Income and Receivables*.

Il-kumment li l-Kunsill ma pprovdix *"any disclosures for its capital commitments"* tirrigwardja nota li nqabżet bi żvista mill-*Financial Statements*.

Rigward il-kwistjoni tal-assikurazzjoni, il-Kunsill qed jimxi preċiżament mar-Regolamenti Finanzjarji tal-Kunsilli Lokali (Leġislazzjoni Sussidjarja 363.01) f'paragrafu 35 (5) li jgħid: "Il-membri tal-Kunsill jistgħu ikunu assigurati fi skema tas-saħħa sakemm dak il-Kunsill ikollu bilanċ pożittiv fil-kontijiet tiegħu jew dik l-iskema ma tirrendix il-kontijiet tal-Kunsill fi żbilanċ."

Kien hemm żjieda fl-użu tal-*Bring-in-sites* tant li filwaqt li f'Jannar ingabru 2.1 tunnellata, f'Settembru din iċ-ċifra telgħet għal 5.9 tunnellata.

Rigward l-iskart imħallat:

Prezentament qed jingabru: 46 tunnellata fil-ġimgħa, (199 tunnellata fix-xahar)

Il-mira għandha tkun: 43 tunnellata fil-ġimgħa, (190 tunnellata fix-xahar).
